MINUTES CITY OF GUADALUPE REGULAR MEETING OF THE RECREATION AND PARKS COMMISSSION WEDNESDAY, NOVEMBER 18, 2020

Call to Order: Recreation Commission Chair- Joe Harris called the meeting to order at 6:03 pm.

Roll Call: Recreation Coordinator Guzman noted the Commissioner Attendance as Follows:

Commissioner Enrique Ortiz- present Commissioner Robert Salinas- present Commissioner Gilbert Robles – present Commissioner Joseph Harris – present Commissioner Tommy Solis Jr- absent

Pledge of Allegiance:

Commission Chair Joe Harris was recognized and led the Commission in the pledge of allegiance.

Community Participation Forum

There was one speaker during the open forum and that was Mr. Ariston Julian, Guadalupe City Mayor. Mr. Julian spoke about the recent city Tax Measure "N" that was recently passed and the necessity for the Recreation Commission to remain vigilant and aware of how the Tax Measure funds will be allocated during the coming year. Mr. Julian emphasized and encouraged the Recreation and Parks Commission to be heard via the Recreation Department Head with respect to the budgeting process and to plan for providing recreational programs that would target meeting the community needs especially since many City voters approved the Tax Measure "N" with the community's Recreational and Parks necessities in mind. Mr. Julian also related that the City Council will be planning a joint meeting with the Recreation Commission to discuss new City goals that would address the needs of the City and community.

Regular Business:

- 1. After review, the Commission voted unanimously to approve the minutes of the last (October 14, 2020) Recreation and Parks Commission meeting based upon a motion by Commissioner Robles and seconded by Commissioner Ortiz.
- 2. The Recreation and Parks Commission then heard from Ms. Sonia Rios-Ventura of the Rural Community Development Corporation of California (RCDCC) regarding the Proposition 68 Grant proposal for the redevelopment of the City's Central Park. Ms. Rios-Ventura provided a nice power point presentation addressing the input and feedback garnered from the various group zoom meetings and community Charette held at the City's Central Park that were initiated, planned and administered by the RCDCC as

required by the Proposition 68 Grant proposal. The final architectural park redevelopment plan was reviewed and discussed with Ms. Rios-Ventura addressing / clarifying questions from the Commissioner Robles on the grant criteria and concerns form an audience member about whether enough outreach was done to inform the community about the proposed redevelopment of the Central Park.

There were two speakers who spoke regarding this agenda item: The first person to speak was a Ms. Alyssa Ruiz a self-professed local Skater form the area. Ms. Ruiz stated that, "She welcomed the proposal and felt the proposal was well designed. Especially since the proposal included a skate park and that there were not a lot of attractions in town in general or especially suited to skaters." She also expressed a, "Desire to be involved with the planning and design layout of the skate park once actually building starts". Ms. Rios-Ventura explained the RCDCC did plan to reach out to the skaters in the Community for their input prior to the building stage if, and when the Grant Proposal receives approval and funding.

The second person to speak was Ariston Julian who rose to speak in favor of the plan presented and proposed by the RCDCC. Mr. Julian echoed the thoughts of the Recreation and Parks Commissioners approving of the RCDCC plan and urging the report and Proposition plan move forward as a positive recommendation to the City Council.

The Recreation and Parks Commissioners voiced unanimously and agreed to recommend that the Proposition 68 Grant Plan move forward. Ms. Rios-Ventura then explained that the Proposition 68 Grant proposal would be presented to the City Council for formal approval during the next City Council meeting on December 8, 2020.

The next phase of Ms. Rios-Ventura presentation involved the discussion and identification of community assets vs the challenges the community faces in the proposal and development Recreation and Parks grant requests.

3. The Commission then turned to the next item on the Agenda in volving the Guadalupe Youth Football Bulldogs Club proposal to purchase, install and establish a snack bar at Jack O'Connell Park utilizing a "C" Train (8'by10') for multi-program purpose use. Recreation Coordinator Guzman reported that he had spoken with the City's Public Works Director-Shannon Sweeney who related some concerns about the exact placement of the "C" Train at Jack O'Connell Park, its maintenance and other possible unforeseen issues. Otherwise in general the project seemed doable.

There was one speaker who was acknowledged regarding this agenda item. Mr. Ariston Julian rose to speak in support of the project. He related that, "The project would be a good starting point to replace a previous snack bar that was no longer in use, especially if it could be used by multi-programs!

After some discussion, the Commission voted unanimously to recommend the acquisition by the Guadalupe Youth Football Bulldogs Club of the "C" Train and its placement at Jack

O'Connell Park, at a site to be determined to be utilized as a snack bar once it is retrofitted to comply with County Health permit requirements. This vote was based on a motion by Commissioner Harris and seconded by Commissioner Salinas.

Staff Request and Announcements:

Staff (Recreation Coordinator Guzman) provided the Commission with the information from the October 2020 Recreation and Parks monthly report to the City Council, noting the continued use of the Senior Community Center as the site for the City sponsored Santa Barbara County Foodbank distribution. In addition, according to Staff the City continues to honor the Federal, State and County COVID-19 restrictions thus hindering the use of City facilities and most community activities. Also, the City Lease agreement for the use of the City Hall Auditorium with the Boys and Girls Club of the Mid Central Coast continues in force and is expected to end at the end of December 2020. The continuation of the lease past December 2020 is still up in the air and is pending a decision by the Boys and Girls Clubs on their plans for a possible lease extension.

Staff also reported on the successful completion of filming on the low budget film "Brut Force LLC." The Production company utilized various areas of the City and City facilities earning approximately 1200 plus in fees for the City.

Commission Requests, Comments and Meeting Reports:

The Commission requested Staff continue to monitor and furnish updates on City Recreation and Parks business especially involving the discussions / negotiations with the (1) American Legion Post 371, (2) The Boys and Girls Club of the Mid Coast use of the City Auditorium via lease, (3) along with any further issues involving the use of City Parks and rental facilities.

Future Agenda Items:

The Commission requested that staff continue to provide updates on current and future grant applications and funding requests for development of Recreation and Park programs and City Beautification doable projects.

Adjournment:

At 8:06 PM a motion was made by Commissioner Ortiz and seconded by Commissioner Robles for adjournment. The unanimous vote resulted in the meeting's closure.
