MINUTES CITY OF GUADALUPE REGULAR MEETING OF THE RECREATION AND PARKS COMMISSSION WEDNESDAY OCTOBER 14, 2020

Call to Order: Recreation Commission Chair- Joe Harris called the meeting to order at 6:01 pm.

Roll Call: Recreation Coordinator Guzman noted the Commissioner Attendance as Follows:

Commissioner Enrique Ortiz- present Commissioner Robert Salinas- present Commissioner Gilbert Robles – present Commissioner Joseph Harris – present Commissioner Tommy Solis Jr- present

Pledge of Allegiance:

Commission Chair Joe Harris was recognized and led the Commission in the pledge of allegiance.

Community Participation Forum

There were no speakers.

Regular Business:

- 1. After review, the Commission voted unanimously to approve the minutes of the last (September 9, 2020) Recreation and Parks Commission meeting based upon a motion by Commissioner Robles and seconded by Commissioner Salinas.
- 2. There was very little discussion on this item. Per staff's (Recreation Coordinator Guzman) update, the City Administration has decided to postpone the negotiations with the American Legion Post 371 until after the first of the year due to complications (COVID-19 issues) in trying to establish / arrange for a meeting with the American Legion Governing Board.
- 3. The Commission then turned to the next agenda item, the possible replacement of a snack bar at Jack O'Connell Park. Commissioner Ortiz took the lead and reported that he has a line on the purchase of a "C" train by the Guadalupe Bulldogs Youth Football Program for \$800.00 that can be converted into use as a multi-program snack bar. The Commission discussed the site placement of the "C" train (10' by 8'), City and County health order compliance rules, and securing an ok from the City (Public Works Director) on the "C" Train's desirable location placement. The Commission voted unanimously based upon a motion by Commissioner Harris and seconded by Commissioner Solis to have Commissioner Ortiz follow through on the potential purchase of the "C" Train and for

Staff to check on an ok from City Administration and Public Works. Also, Commissioner Ortiz reported that the Youth Football season is still on hold due to COVID-19 issues.

- 4. Staff reported to the Commission that due to COVID-19 restrictions there has been minimal use / utilization of Recreational facilities at Jack O'Connell park and other city facilities. Although there have been some unauthorized "organized" use of the Jack O'Connell Park's horseshoe and softball / baseball fields for formal organized (tournament style) play. The City Police and City Public Works departments have responded by placing notices prohibiting further formal "organized" use. Although informal use and play is still allowed in the park.
- 5. Staff updated the Commission on the upcoming RCDCC "Charette "event on Saturday 10/17/20 at the City's Central Park to introduce the various planned ideas, additions and renovations to the Central Park Renovation proposed Proposition 68 grant project. After discussion and review of the planned "Charette", the Commission seemed very pleased with the project's direction.
- 6. Staff reported that the City Council approved the rental lease agreement for use of the City Hall Auditorium by the Boys and Girls Clubs of Mid Central Coast. The Club began use of the Auditorium per the lease agreement effective 10/5/2020. There were a couple of minor hiccups, but for the most part the lease agreement and use by the Club is going well.
- 7. With respect to Agenda Item 7, after some discussion the Commission requested a continuation of this item as an ongoing future agenda item in that the update and repair of the City hall Auditorium required more planning, thought and development.
- 8. The Commission then turned it attention to final agenda item, the Beautification to the City's entrance and exit corridors. After much discussion, the Commission suggested that Staff draft a list of doable projects so that the Commission can narrow down its focus on the most desirable and feasible projects.

Staff Request and Announcements:

Staff (Recreation Coordinator Guzman) provided the Commission with the information from the September 2020 Recreation and Parks monthly report to the City Council, noting the continued worthwhile use of the Senior Community Center as the site for the City sponsored Santa Barbara County FoodBank distribution.

In addition, staff reported on the following week's expected filming of a low budget film by "Brut Force LLC." Production company that will be utilizing various areas of the City and City facilities.

Commission Requests, Comments and Meeting Reports:

The Commission requested Staff continue to monitor and furnish updates on City Recreation and Parks business especially involving the discussions / negotiations with the (1) American Legion Post 371, (2) The Boys and Girls Club of the Mid Coast use of the City Auditorium via lease, (3) along with any further issues involving the use of City Parks and rental facilities.

Future Agenda Items:

The Commission requested that staff continue to provide updates on current and future grant applications and funding requests for development of Recreation and Park programs and City Beautification projects.

Adjournment:

At 7:58 PM a motion was made by Commissioner Ortiz and seconded by Commissioner Robles for adjournment. The unanimous vote resulted in the meeting's closure.
