MINUTES

CITY OF GUADALUPE SPECIAL MEETING OF THE RECREATION AND PARKS COMMISSSION WEDNESDAY, FEBRUARY 24, 2021

Call to Order: Recreation Commission Chair- Joe Harris called the meeting to order at 6:00 pm.

Roll Call: Recreation Coordinator Guzman noted the Commissioner Attendance as Follows:

Commissioner Enrique Ortiz- present Commissioner Robert Salinas- present Commissioner Tommy Solis Jr. absent Commissioner Joseph Harris – present Commissioner: Open Position

Pledge of Allegiance:

Commission Chair Joe Harris was recognized and led the Commission in the pledge of allegiance.

Community Participation Forum

There were no official speakers.

Regular Business:

- 1. After review, the Commission voted unanimously to approve the minutes of the last (January 13,2021) Recreation and Parks Commission meeting based upon a motion by Commissioner Ortiz and seconded by Commissioner Salinas.
- 2. The Commission listened to various proposals from Ms. Shannon Sweeney- City Public Works Director, who was representing her son in his Eagle Scout Candidacy. These doable renovation / beautification projects included plans, objectives and budget information. The Commission unanimously agreed that the proposals were a welcome addition to the City Park facilities. Furthermore, the Commission felt that that project task proposed for the Jack O'Connell Park playground renovation seemed to be the best fit. It was agreed that Ms. Sweeney should meet with her son (and any other Eagle Scout candidate who wished to partake in the project) on whether the Jack O'Connell Park playground was a project he wished to take on for his Eagle Scout Candidacy and return next month with his decision and plan, budget requirements to accomplish the renovation tasks.
- 3. The Commission decided to hold any further discussion on this item pending the results of the upcoming City-Wide goal setting meeting planned for 3/6/2021.

- 4. The Commission decided without a vote to table this item presently and elected to do some further study on their own before moving forward with any specific plan but would furnish feedback to staff prior to the next Commission meeting in April 2021.
- 5. After some discussion, The Commission committed individually to attending the City-Wide goal setting meeting and would provide individual feedback to staff prior to the scheduled City-Wide Goal setting meeting (3/6/2021) regarding their individual "SWOT" analysis on City strengths and weakness in reference to the Recreation and Park department and city facilities.
- 6. The Commission discussed the "Capital Campaign" proposed by the RCDCC for the LeRoy Park renovation project. All Commissioners expressed their positive support and were pleased that the City Council's approved and adopted the RCDCC's LeRoy Park "Capital Campaign" request.
- 7. After review and some discussion, The Commission unanimously approved the recommendation that the City Council approve the "City Policy on the use of the Veteran's Memorial Plaza" as written based on a motion by Commissioner Ortiz and a second by Commissioner Salinas.

In addition, after some discussion regarding the present fee schedule, the Commission decided to revisit and clarify during a future Commission meeting, the fee schedule policy with respect to the amount that will be charged to Non-Profits located outside the City of Guadalupe. The idea in question is whether to charge the same city designated non-profit rate, for use of City facilities, to all Non-Profits working in cooperation with the City of Guadalupe to provide affiliated / co-sponsored services to Guadalupe City residents. Based upon a motion by Commissioner Salinas and seconded by Commissioner Ortiz, the motion was unanimously approved to revisit this issue and provide a clarifying recommendation / amendment to the present city fee schedule for consideration, approval and adoption by the City Council.

Staff Request and Announcements:

Staff reviewed the Recreation and Parks monthly report for January 2021 without discussion. Staff also provided updates to the renovation projects involving LeRoy and Central Parks.

On a lighter note, Staff and Commission commended Commissioner Ortiz' involvement with the Guadalupe Community Clean-ups and Commissioner Salinas' help with the volunteer efforts of the City sponsored Santa Barbara County Foodbank.

Commission Requests, Comments and Meeting Reports:

The Commission requested Staff continue to monitor and furnish updates on City Recreation and Parks business especially involving the LeRoy and Central Park Renovation projects, the RCDCC Capital Campaign. Also, the Commission requested that they be kept in the loop regarding any further developments involving the status of the lease agreement for the City owned Veterans Hall with the American Legion Post 371.

Future Agenda Items:

The Commission requested that staff continue to provide updates on current and future grant applications. Discussion regarding the "Capital Campaign" funding resolution request by the RCDCC for The LeRoy Park Renovation. Discussion on the development of future Recreation and Park Commission sponsored programs. Possible further discussion(s) on items or issues to be targeted by the Recreation and Parks Commission as a result of and /or with respect to the upcoming City-Wide Goal Setting meeting(s).

Adjournment:

At 8:30 PM a motion was made by Commissioner Salinas and seconded by Commissioner Ortiz for adjournment. The unanimous vote resulted in the meeting's closure.
