MINUTES

CITY OF GUADALUPE

SPECIAL MEETING OF THE RECREATION AND PARKS COMMISSSION WEDNESDAY, March 10, 2021

Call to Order: Recreation Commission Chair- Joe Harris called the meeting to order at 6:36 pm.

Roll Call: Recreation Coordinator Guzman noted the Commissioner Attendance as Follows:

Commissioner Enrique Ortiz- present Commissioner Robert Salinas- present Commissioner Tommy Solis Jr. absent Commissioner Joseph Harris – present Commissioner: Open Position

Pledge of Allegiance:

Commission Chair Joe Harris was recognized and led the Commission in the pledge of allegiance.

Community Participation Forum

There were no official speakers.

Regular Business:

- 1. After review, the Commission voted unanimously to approve the minutes of the last (January 13,2021) Recreation and Parks Commission meeting based upon a motion by Commissioner Salinas and seconded by Commissioner Ortiz.
- 2. Staff (Coordinator Guzman) reported to The Commission that Eagle Scout candidate Mr. Kevin Sweeney has chosen and agreed to pursue the Jack O'Connell Park children's playground renovation project in hopes of fulfilling his "Eagle Scout Candidacy" requirement. This doable renovation / beautification project will include plans, objectives and budget information presently estimated to cost \$5000.00. Public Works Director Sweeney related that She and Kevin will pursue a grant via Home Depot Corporation in order to fund the project during the upcoming fiscal year. The Commission agreed to discuss this item and make a formal recommendation to the City Council once the project plan is in place, funded and ready to move forward. Furthermore, the Commission unanimously agreed that the project task proposed for the Jack O'Connell Park playground renovation seemed to be the best fit and were pleased with the efforts of Public Works Director Sweeney and her son Kevin Sweeney.
- After discussion, The Commission decided to recommend that an ADHOC committee be formed to address this agenda item based on a motion from Commissioner Harris and seconded by Commissioner Ortiz. The ADHOC committee volunteers will consist of

Commissioners Harris and Ortiz. The ADHOC committee will narrow down the various ideas discussed form the following list:

Halloween Carnival.

Community 5K Run and Bicycle ride, Recreation and Parks T-Shirt fundraiser.

Monthly Bingo.

Community Fourth of July Event.

Collaboration with the City's Hispanic organizations in expanding the Hispanic cultural celebration activities.

Collaboration with City Auto Clubs on a community event(s).

City Cultural Diversity event.

Development of City-Wide Basketball, Horseshoe and Handball tournaments.

- 4. The Commission decided after some discussion to appoint an ADHOC committee to address this agenda item with respect to the recent City Goal-Setting meeting. This was based on a motion by Commissioner Salinas and a second by Commissioner Ortiz. Commissioners Salinas and Harris volunteered to head this committee and thus were appointed.
- 5. After some discussion, The Commissioners all expressed their agreement with the City Council's decision to approve the Capital Campaign for the fundraising effort to complete the Renovation of LeRoy Park and pledged their continuing support for the project.
- 6. Staff (Coordinator Guzman) updated the Commission on the status of the City's Central Park project. According to the RCDCC the grant request was submitted to the State (3/8/2021) on time and a response from the State in late summer.
- 7. After review and some discussion, The Commission agreed that the City's position for continued City-wide facilities closure should remain in effect until the City and the County's current Tier status is changed by the State.

Staff Request and Announcements:

Staff reviewed the Recreation and Parks monthly report for February 2021 without discussion. Staff also provided updates on the status to fill the open Recreation and Parks Commission position. Staff reported that a few candidates have expressed interest and hopefully will pursue their interest with a request to the City for appointment to the Commission.

Commission Requests, Comments and Meeting Reports:

The Commission requested Staff continue to monitor and furnish updates on City Recreation and Parks business especially involving the LeRoy and Central Park Renovation projects, the RCDCC Capital Campaign.

Also, after some discussion regarding the various volunteer efforts ongoing throughout the community in the past year, a motion was made by Commissioner Harris and seconded by Commissioner Salinas that the Recreation and Parks Commission recommend to the City Council that those volunteers who are providing City beautification (Clean-up) and foodbank services be acknowledged and recognized by the City Council in some form. The vote was unanimous in favor of the recommendation.

Future Agenda Items:

The Commission requested that staff continue to provide updates on current and future grant applications along with any results from the City's negotiation efforts with the American Legion Post 371 on the use of the City owned Veterans Hall.

In addition, the Commission would also like to pursue further discussion on future Recreation and Park Commission sponsored programing. Specifically, programming items or issues to be targeted by the Recreation and Parks Commission as a result of and /or with respect to recent City-Wide Goal Setting ADHOC committee meeting recommendations.

Adjournment:

At 8:11 PM a motion was made by Commissioner Salinas and seconded by Commissioner Ortiz for adjournment. The unanimous vote resulted in the meeting's closure.
