MINUTES

CITY OF GUADALUPE SPECIAL MEETING OF THE RECREATION AND PARKS COMMISSION TUESDAY, JUNE 21, 2022

Call to Order: Recreation Commission Chair- Joe Harris called the meeting to order at 6:00 p.m.

Roll Call: Recreation Manager, Hannah Fuentes, noted the Commissioner attendance as follows:

Commissioner: Enrique Ortiz- Present
Commissioner: Robert Salinas- Present
Commissioner: Jesse Ramirez- Absent
Commissioner: Emily Dreiling - Absent

Pledge of Allegiance:

Commissioner Chair Joe Harris was recognized and led the Commission in the pledge of allegiance.

Community Participation Forum:

No participation.

Consent Calendar:

1. Motion was made by <u>Salinas</u>, seconded by <u>Ortiz</u> to approve the June 8, 2022, minutes. All ayes, 3/0. Motion passed.

Regular Business:

1. Le Roy Community Center Mural Selection

The Commission reviewed and discussed all of the submissions presented. There were four total. The Commission was directed to choose three to move forward to City Council and eliminate one.

Submission #1 was eliminated for the following reasons:

- Submission was not a painting
- Art was "busy"
- Nothing submitted indicating where this would be applied to the building

Submission #2 was chosen as the first-place submission for the following reasons:

 Depicted children playing which represents activities that would take place at LeRoy Park Included Guadalupe history by using a 1950s agricultural poster as the background of the art

Submission #4 was chosen as the second-place submission for the following reasons:

- Depicts children playing at the park
- Has multiple Guadalupe cultural references
- Contains the history of Guadalupe
- Fit the dimensions well

Submission #3 was chosen as the third-place submission for the following reasons:

- Depicts the diverse community of Guadalupe
- Includes a few Guadalupe culture ideas
- "Busy"

The Commission recommended submissions in winning order to be presented to the City Council at the July 12th meeting for the council to choose the winner. The winner will then be asked to attend the July 13th Recreation and Parks Commission meeting to receive feedback from the commission. At that time, the winner will be asked to take feedback into consideration and return to the next Recreation and Parks Commission meeting to present a final draft of their art.

2. Auditorium Ad Hoc Committee Verbal Update

Heaters installed, electrical completed, mats are in place, and repairs to the ceiling and windowsills completed. RFQ for painting completed and sent out. The stage floor work is complete. Deposit for curtains paid, waiting on delivery. C-Train delivered. Commissioner **Ortiz** recommended that windows or some type of ventilation be installed in the C-Train.

A stage curtain has been recommended. There is currently no funding to purchase a stage curtain and curtain tracks. Ms. Fuentes updated the Commission on the option of running fundraisers through a non-profit in order to bring in revenue to pay for Recreation & Parks Department needs without having to take money directly from the general fund.

3. Jack O'Connell Ad Hoc Committee Verbal Update

The play structure is done, final walk-through completed on June 6th. The fence was taken down and has been accessible since 06/07/2022. A celebration took place on Saturday, June 11th at 1pm. Free ice cream was handed out and free face painting was provided to children at the event.

Ms. Fuentes updated the commission on the shed located at O'Connell and whether it could be permitted to run concessions out of. A public health inspector informed Ms. Fuentes that it would be more efficient to create an entirely new concession area than it would be to remove and rearrange the shed to met code.

4. Guadalupe Color Fusion 5k

The color run will take place on Saturday, July 30th at Jack O'Connell Park. Check in will start at 9am and the run will start at 10am. The course will consist of three laps to be equivalent to a 5k. Participants can choose how many laps they would like to run/walk. The cost will be \$20 per person with the registration packet included and \$10 without the registration fee. The registration packet includes choice of a water or sports drink, a snack, a shirt, an individual color packet, and a participation medal.

5. Los Puentes Unidos Resource Fair

SER Jobs for Progress from Fresno, Community Center of the Arts & Technology from Fresno, and Folklorico El Padrecito have teamed up with the City to plan a resource fair bridging the Fresno and Guadalupe community. The resource fair will provide the opportunity for residents of Guadalupe to connect with all types of organizations that provide services and programs for the community. Plays that address the struggles of COVID-19 pandemic will be performed in addition to other dance performances. The groups that will be attending are being asked to put together a raffle item. The only requirement for attendees to enter into the raffle is that they visit each booth and turn in their "passport" with their name to the Recreation Department table.
