WHEREAS, child abuse and neglect are a community condition and problem, and finding solutions depends on involvement among people in the community; and

WHEREAS, Child Welfare Services had 2,748 referrals in the north county for possible abuse in 2022/2023; and

WHEREAS, the effects of child abuse and neglect are felt by whole communities and need to be addressed by the entire community; and

WHEREAS, North County Rape Crisis and Child Protection Center and its CAPC partners have been committed to educating our community on child abuse and neglect and are sponsoring several events throughout the month to heighten public awareness of abuse in the Northern County of Santa Barbara. These events will provide information and materials that support families to prevent child maltreatment and celebrate people who work with and support children and families; and

WHEREAS, effective child abuse prevention programs succeed because of partnerships created among social service agencies, schools, youth organizations, religious organizations, civic organizations, law enforcement agencies, the business community, and residents; and

WHEREAS, all residents should become more aware of the importance of prevention in the community and become involved in supporting parents to raise their children in a safe nurturing environment.

NOW, THEREFORE, BE IT RESOLVED, that by virtue of the authority vested in me as Mayor and on behalf of the City Council of the City of Guadalupe, I, Ariston Julian, do hereby proclaim April 2024 as **NATIONAL CHILD ABUSE AWARENESS & PREVENTION MONTH** in the City of Guadalupe, and call upon all residents, community agencies, religious originations, businesses, and medical facilities to increase their participation in the effort to prevent child abuse.

SEXUAL ASSAULT AWARENESS & PREVENTION MONTH - APRIL 2024

WHEREAS, people of all racial, cultural, and economic backgrounds fall victim to sexual assault, sexual violence is widespread and impacts every person in this community. Rape, sexual assault, and sexual harassment harm our community, and statistics show child sexual abuse prevention must be a priority to confront the reality that one in six boys and one in four girls will experience a sexual assault before age 18; and

WHEREAS, those numbers change to more than 1 in 3 women will experience sexual violence in their lifetime and 1 in 4 men will experience sexual violence in their lifetime; and

WHEREAS, rape and sexual violence of all kinds continue to occur at an alarming rate, with California having the most reported rapes in the United States, and with the Department of Justice stating that an American is sexually assaulted every 98 seconds in the United States; and

WHEREAS, emotional and physical scars resulting from sexual violence are often permanent; therefore, working together to educate this community about sexual violence prevention, supporting survivors, and speaking out against harmful attitudes and actions is so important; and

WHEREAS, a coalition of organizations exist, which directly confronts this crisis, including North County Rape Crisis and Child Protection Center, law enforcement agencies, churches, health care providers, and volunteers from the community that serve these agencies, who are helping in the effort to end sexual assault; and

WHEREAS, prevention is possible when everyone gets involved increasing education, awareness, and community involvement; recognizing the compassion and dedication of the individuals involved in this effort; and noting the challenges of the victims/survivors of sexual assault and their families and friends as they struggle to cope with the reality of sexual violence.

NOW, THEREFORE, BE IT RESOLVED, that by virtue of the authority vested in me as Mayor and on behalf of the City Council of the City of Guadalupe, I, Ariston Julian, do hereby proclaim April 2024 as SEXUAL ASSAULT AWARENESS & PREVENTION MONTH and encourage all residents and businesses to participate in a month full of recognition and activities promoted by the North County Rape Crisis and Child Protection Center to increase awareness of sexual assault and to create solutions in an effort to eliminate sexual violence from this City.

MINUTES

City of Guadalupe Regular Meeting of the Guadalupe City Council Tuesday, March 26, 2024, at 6:00 pm City Hall, 918 Obispo Street, Council Chambers

1. ROLL CALL:

Council Member Christina Hernandez Council Member Gilbert Robles Council Member Whitney Furness Mayor Pro Tempore Eugene Costa Jr. Mayor Ariston Julian

Mayor Julian called the meeting to order at 6:00 p.m. All were present. (Note: The abbreviation, "CM" for "Council Member," will be used in these minutes.)

2. PLEDGE OF ALLEGIANCE

3. MOMENT OF THANKS, APPRECIATION OR CONDOLENCES.

Mayor Julian gave condolences for the six (6) individuals missing in the Baltimore bridge collapse. He also mentioned the passing of Esperanza Abril, a long-time resident of Guadalupe. Services will be next week. Condolences to the family. Prayers for peace in the Middle East.

4. AGENDA REVIEW

There were no changes to the agenda.

5. CEREMONIAL CALENDAR

• Proclamation – Expressing appreciation to Hannah Sanchez for her services as Recreation Services Manager of the City of Guadalupe

Mayor Julian read the proclamation which in part said: "...Hannah Sanchez was hired as Recreation Services Manager on January 10, 2022 and provided professional recreation management to the City, helping generate a commitment to continuous improvement to this growing department that will continue well into the future...[she] has exhibited her strong sense of civil service, dedication to providing excellent recreational and park service, and professional expertise...began upgrades and renovations to all our facilities and parks...developed partnerships with outside organizations to bring more programs to Guadalupe for all ages of the community...created annual events and activities...and collaborated with other organizations to bring about the Grand opening event of Le

Roy Park, Dia de los Muertos Celebration...ran both adult drop-in sports nights and sports leagues...the City has benefited from Hannah Sanchez's commitment of time, energy, knowledge, and intelligence in numerous projects, initiatives and matters in order to grow the recreational opportunities in Guadalupe." Mayor Julian said, "Gonna miss you."

Mr. Bodem read an email from Shirley Boydstun: "The Friends of the Guadalupe Public Library, and Rancho de Guadalupe Historical Society and I, personally, wish to thank Hannah for her steadfast assistance to each of us in scheduling events and getting notices on the Royal Theatre marquee. Well done. Bien hecho, Hannah. Enjoy your new phase of life." Shirley Boydstun

Ms. Sanchez was given the opportunity to say a few words but politely declined.

6. PRESENTATION

A. Guadalupe 9th Street Bridge Mural – 2024 Community Project

Ms. Stephanie Krouse said, "For twenty-six years I've lived in Guadalupe. About four (4) years ago, I started painting murals in Guadalupe. This year, the Little House at the Park/FSA and Guadalupe Community Changers contracted artists who are paid by a grant. We want to get the community involved in these activities. Arnulfo Navarro suggested we paint the 9th Street pedestrian bridge. I usually cross the bridge. I see graffiti there but with murals, people may leave it alone. I had done a mural on 9th Street with Gilbert (CM Robles). People waited to see it and then left it alone. Power of art is great."

Mr. Arnulfo Navarro, referred to as "Nufo," gave a brief presentation on this project:

The 9th Street bridge is a long-standing community bridge. I've always loved this bridge. It's used in different ways. It is a meaningful community bridge. Standing on the south side of the bridge looking north, the west side pillar is "dusk," and the east side pillar is "dawn." Transients coming daily through on Amtrak. They will see these images. People will recognize them and put Guadalupe on as a train destination.

Guadalupe is a town of migrants and their "suitcases." Ancestors got us here. A lot of people coming and going during the years. There were the Swiss-Italians, a small percentage of Mexicans, large Japanese population as well as a large Filipino population. That shifted in World War II when the Japanese were ripped from our community.

There are many businesses that helped to build our community, such as Masatani's Market, La Simpatia, El Tapatio and Two Guys Pizza. There's an opportunity for more funding if the names or logos of those businesses are on the bridge. They have longstanding roots in our community. There would be a specific area on the bridge for painting community members, whether current or past. They pointed us in the right direction. This would be our way of paying homage to them.

This would also be a chance to put your family name on the bridge as part of this community project. There would be music, food...like a block party to involve community members to have fun to have this bridge forever.

As far as our project outlook, the budget has yet to be developed. Not only would it involve the costs of the art supplies but the cleaning, washing and general initial preparation of the bridge. Then there's the timeline of when to start and how long it might take. For support, we're looking at "all hands-on deck".

The murals would be our story, told by us. It would be community beautification with community involvement. People care about what they work on. They don't want to see anyone mess with it. "It's ours." The mural would enrich Guadalupe. It would be one of Guadalupe's landmarks to those passing through on a train and for our community.

Mayor Julian commented, "Thinking outside the box. This does it. With the Central Park revitalization...this ties right into the bridge. The jail and the Historical Society encompass a lot of history. You mentioned a lot of that history...the Japanese, Chinese, Filipinos, the field workers. It would be a tribute to the community. Did we put the bridge there or did the Pacific Railroad?" City Attorney Sinco said, "Permits may be needed. We will look into it."

The mayor continued saying, "There's the barbershop near there. Use the park as a venue. Block out the street to have events there by the bridge. That's a great project. Budget...what's your timeframe? If you have all the money in the world, what's your timeframe?" 'Nufo' said, "We should start this project the week after kids get out of school...summer months." Mayor Julian said, "Yes, community involvement." 'Nufo' added, "Adults would be involved, too. Not just for kids. But we could paint an outline and let the kids go do it. Amtrak has a budget for arts. That's an avenue to be researched for budget."

CM Hernandez said, "Thank you for this project. Our story...told by us. I think that's really important, especially coming from Guadalupe residents. I actually posted something in 2020. There was a video that I found. It was an FBI raid. April29, 1942...rounding up Japanese, taking two suitcases and taken from their homes. Many of them never to return. Many of these stories are heartbreaking. We need to make sure these stories are told."

City Attorney Sinco said, "We will have to bring this item back. There's no promise." Mayor Julian said, "There's a promise to support this." City Attorney Sinco added, "This was only information only. It was not agendized."

B. Guadalupe Broadband Survey – Results and Update

Mr. Garret Matsuura gave a brief background on why this survey was undertaken: This was the first census-style survey done in the County. It's used as a pilot for other communities. It was done to get the most accurate data available on the baseline existence and quality of broadband services within the City of Guadalupe. Without reliable broadband within the business districts, the ability for the City to attract new businesses would be at a significant disadvantage.

Some of the key pieces of this presentation are as follows:

• To be inclusive as possible, the surveys needed to be short to the point, and available in English and Spanish.

- Unique feature of this survey was to focus on using local canvassers to conduct the survey an in-person request would generate stronger responses.
- The aggregate survey response rate for Guadalupe was about 50%.
- Out of about 1100 respondents, 998 said they were connected to the internet at home while 99 said they weren't.
- Majority connected via WiFi. Smaller percentages used Cellular Hotspots, Satellite connections or their Cell Phones to connect.
- The community seems to be satisfied with speed.
- Spectrum had the highest usage; Frontier was second.
- Most people don't understand the terms "Fiber" or "Broadband."
- If an internet service were a public utility, 85% said they'd use it; 13% said they wouldn't.

Mr. Matsuura said, "Knowing that the City can't staff for internet service provider, the City would have to work with other cities/agencies within the County. There are two (2)models that provide internet services, fiber network through a community that provides for competition. There's Idaho and Utah, not that we'd use those services. But if you have Spectrum, you're probably paying between \$100-\$150 a month for internet. In Utah, for example, for faster service, you'd pay about \$50 a month."

Mayor Julian asked, "What's the next step?" Mr. Matsuura said, "We're waiting for results from SBCAG's discussion with the State. Hopefully, whether the data would help with Spectrum's objection...maybe we'll hear something in April or June."

Mr. Bodem asked, "What's the difference between broadband and fiber?" Mr. Matsuura said, "Broadband is more of a general term. It's really between cable and fiber."

7. COMMUNITY PARTICIPATION FORUM

Request to Speak

Gloria Villegas, Outreach Coordinator at Dunes Center, gave an update on activities at the Dunes Center. This weekend, Saturday, March 30th, "Coastal Stories" will be presented at the Red Barn here in Guadalupe. This event will be from 11:30 a.m. to 3:30 p.m. This will be a multi-celebration showcasing Native Americans, the Hispanic community...trying to tell a story in what we're doing in our documentary. Stories of our cultures. There will be AV booth, photo booth...people can come in and record any story, maybe a story your grandma told you. These stories bring richness and depth to our community. There will be burgers, activities for kids. This will be a city-wide opportunity to highlight the importance of the Dunes Center. Let us know people who should be interviewed. Hearing voices of the community – Coastal Stories.

Also, next month we'll have a coastal cleanup now that the Guadalupe Beach is open. We're partnering with "Earth Day." There will be activities and informational booths.

MANAGEMENT REPORTS

9. **CITY ADMINISTRATOR REPORT**: (Information Only)

Mr. Todd Bodem reported the following:

Introduced the new Recreation Services Manager, Annis Barajas. Ms. Barajas said, "I'm excited to join the City of Guadalupe and serve the community."

On the morning of Saturday, 6/08/24, the Sri Chinmoy Oneness Home Peace run would like to hold a Peace Run when it passes through Guadalupe. Their goal as runners and peace lovers is to give each person they meet a chance to share their own hopes and dreams for a more positive and inspired world...as it has meaning in their own communities and in their own way. They would hope to meet the Mayor and our staff in a convenient location to share the Peace Torch and introduce the community to their global team...A celebration of peace.

The APCD would like to hold a replacement air filter giveaway on Tuesday, April 16^{th} at the City Council Chambers at City Hall from 12:00 p.m. to 6:00 p.m.

Alison Wales, Associate Director from the North County Rape and Child Protection Center, will hold a recognition planting pinwheels in the area. This year they will plant 396, part of which will be planted on the City Hall grass on April 4^{th} at 10:00 a.m. A proclamation will be read.

The UCSB BREN Master program has decided not to pursue working on a "Climate Action Plan" for the City as they have chosen other projects. This would have been free for the City as these plants are very expensive. Instead, City staff is working with Dr. Nuworsoo from Cal Poly Urban Planning Department to see if their students can work on this as a project in their master's program.

On April 1st, the City will submit a pre-application for an assembly member and congress member "earmark" in the amount of \$2M for a senior center remodel, renovation, and/or new building construction. Devon Thomas, Townsend Public Affairs (grant writer) will assist city staff in writing the application. Devon has replaced Christine Rose as our grant writer. A support letter has been signed by the Mayor and submitted for the pre-application.

State Parks has allowed for an extension of the Central Park project from 2026 to 2028. This is a contract amendment.

In reference to the pinwheels to be planted on April 4th CM Hernandez mentioned that there will be 395 pinwheels planted, one for every five child abuse investigations in the Santa Maria region in 2023.

10. DIRECTOR OF PUBLIC SAFETY REPORT: (Information Only)

- A. Police Department report for February 2024
- B. Code Compliance report for February 2024

Chief Cash said he wanted to show appreciation to our artists. He said that the murals do decrease graffiti. The painting of the 9^{th} Street Bridge is an awesome project.

There are some long-term code compliance issues regarding various homes. Information will eventually be given to our City Attorney. We're looking at problematic homes that we keep going back to. There are provisions for charging for police services on regular type of calls. More information will be out in the future. Just something to be aware of now.

I'm honored to say that on April 3rd, at the Guadalupe Social Club, Kevin Costner will receive a Service Award. The staff has done an amazing job...the Recreation Department, Administration, etc. To make this happen is huge. Kevin Costner said that maybe Guadalupe's a location for a movie in our community. Donating services and time. We'll talk more about this as we put the finishing touches on it.

Mayor Julian asked, "Why is he getting accolades?" Chief Cash said, "Last year, 2023, there was the flooding in Guadalupe. Over fifty residents who lost their homes were brought to City Hall. We didn't have a designated shelter. There was no heat, water, lights, no food source...it was a dire situation. The Red Cross trailer was the only thing we had then. We brought that information to One805, a charitable organization that was founded as a result of the flood and mudslides in Santa Barbara. There was a large loss of life during that flood. They brought together events to raise money for equipment that cities couldn't afford. Guadalupe needed a generator. The event was on Kevin Costner's property. Monies were raised for first responders throughout the Santa Barbara County. We were granted \$50,000 and another \$30,000 from the City Council for a generator that will be housed here at City Hall. We can now have an evacuation center. Kevin Costner spoke up on Guadalupe's behalf. This is the first generator in the City."

CM Hernandez said, "I met one of the One805 board members. They should receive a letter from the City acknowledging their charitable work."

11. INTERIM HUMAN RESOURCES MANAGER (Information Only)

A. Human Resources report for February 2024

Ms. Villegas reported that recruitment continues for the following openings: Police Officer, Senior & Community Center Activities Coordinator, Public Works Director, Maintenance Worker I, Multimedia Assistant/Building Attendant and Grants Administrator. As was mentioned in the City Administrator's report, Ms. Annis Barajas was recently hired as Recreation Services Manager. The full-time Human Resources Manager position was filled by Ms. Sylvia Estrada who started on Monday, March 18th.

Other items: Labor negotiations with IAFF Local 4403 are ongoing. One first aid injury was reported in February. HR files continue to be updated not only to ensure correct chronology of salary changes and employment history, but also to ensure documents not appropriate for an HR file are removed and filed elsewhere, as applicable. Training was discussed with CJPIA. The first training to be scheduled will be "Preventing Discrimination and Harassment in the Workplace." This will be an onsite training by CJPIA.

PUBLIC HEARING

12. Consider amendments to the Subdivision Ordinance, Title 17, Section 17.32.030.A. of the Guadalupe Municipal Code.

Written report: Larry Appel, Contract Planning Director

Recommendation: That the City Council:

1. Receive a presentation from staff; and

2. Conduct a public hearing and introduce by title only and waive the first reading of Ordinance No. 2024-517 amending Section 17.32.030 of the Guadalupe Municipal Code; and

3. Continue to April 9, 2024, for second reading and adoption.

Mr. Appel summarized this item: The City's General Plan was updated in November 2022. Shortly thereafter, the zoning ordinance was amended to ensure that all zoning designations were consistent with the new land use designations. Allowing a higher density in all three (3) residential zone districts was also a piece of the General Plan update.

What has resulted from that General Plan update is a current inconsistency with Title 17, the City's subdivision ordinance which requires a minimum lot size of 6,000 square feet and a minimum lot width of 60 feet. With the new single-family densities, a lot can be as small as 3,630 square feet. Along with the reduced lot size, staff is also recommending a reduction in lot width from 60 feet to 45 feet. Amending Title 17 to reflect these changes will be necessary.

Public Hearing opened at 7:15 p.m. and closed at 7:16 p.m.

Motion was made by Council Member Costa, Jr. and seconded by Council Member Robles to approve first reading of Ordinance No. 2024-517. Roll Call: Ayes: 5 5-0 Motion passed.

REGULAR BUSINESS

13. Approving hiring of Bond Financial Team for the Guadalupe Royal Theater Renovation Project.

Written report: Todd Bodem, City Administrator

<u>Recommendation</u>: That the City Council adopt Resolution No. 2024-26 approving the hiring of a bond financing team (Jones Hall, A Professional Law Corporation as bond counsel and Wulff, Hansen & Co. as municipal advisor) for the Guadalupe Royal Theater Renovation Project.

Mr. Bodem gave a brief background and purpose of this item: The Royal Theatre was built in 1939 and was a functioning motive theatre in the community until its closure in 1989. From then the building had various uses until 2011, when it was red tagged due to a minor interior electrical fire. Through a purchase by the former Redevelopment Agency of the City of Guadalupe (RDA) in 2001, then the dissolution of the RDA ownership, the Royal Theatre was transferred to the Successor Agency (SA) in 2012. State law required the SA to adopt a Long-Range Property Management Plan. Such plan stipulated that the theatre should be transferred to the City which, then, should be renovated as some form of Public Performing Arts Center.

The Royal Theatre Renovation Project is being undertaken by the City to (1) reconstruct, rehabilitate, and renovate, to historic standards, the Royal Theatre, and (2) construct an additional, connected 3-story performing arts center, amphitheater, and community plaza. This project is an essential project of public infrastructure for the City as it is part of the basic, underlying features of the City's physical landscape, community identity, and organization.

The City has worked diligently to raise the necessary funds for this project. To date, the City has secured, or is in the process of securing more than \$10 million in grants and other financing.

Anticipated funding:

- Economic Development Administration (Eda) grant (\$4.8 million)
- California Arts Council-State Legislative Passthrough Funding (\$5.0 million)
- Historic Tax credit (HTC) investments (approximately \$0.8 0.9 million)

Although final costs are not yet available, the City believes that an additional amount of approximately \$3.0 million, and potentially up to \$5.0 million, is required to ensure the project can be completed as designed. A key point to emphasize is that the timelines for obtaining funding is running short, as the \$4.8 million EDA grant will expire if construction is not started by March 2025.

Mr. Bodem then discussed the option of placing a bond measure on the November 2024 ballot appears to be the best option to ensure the funding for this project is in place in a timely manner. He also emphasized that to put a bond measure on the November 2024 ballot, specialized consultants are required. The firm, Jones Hall, A Professional Law Corporation, would serve as bond counsel to the City, and Wulff, Hansen& Co. would serve as municipal advisor to the City. The fee proposals are \$10,000 for Jones Hall and \$5,000 for Wulff, Hansen & Co. An additional fee, estimated to be no more than \$5,000, would be charged by the Santa Barbara County Elections Department for placement of the measure on the November 2024 ballot.

If this financing consulting team were hired, they would work with City staff to further analyze a potential bond measure to bring back to the City Council additional action items. These additional items, such as the professional services agreements for these consultants, would be anticipated to occur in June and July, in order to meet statewide deadlines for the November 2024 election. Mr. Bodem said that the total estimated costs would be \$20,000. These funds would initially be paid from the City's FY 24/24 budget, not the current budget. If the measure fails, the General Fund would be impacted by these costs. However, if the measure passes, the City could consider reimbursing the General Fund from the bond proceeds.

At this point, Mr. Bodem introduced Mr. James Wawrzniak from Jones Hall and Mr. Steven Gortler from Wulff, Hansen& Co., who then gave their presentation on financing options for the Royal Theatre Revitalization Project. Some of the salient points were:

- Estimated total cost of the project is between \$12 million to \$14 million. The City already has approximately three-fourth of the cost; grants don't have to be repaid.
- Approximately \$2 million to \$5 million of additional funding is needed to cover the remaining costs of the project.
- With tax exempt bonds, the City receives the monies upfront...pay back over 25-30 years.
- Lower interest rate a benefit for local agencies to fund capital projects; local governments are fairly stable and credit worthy.

- General Obligation Bonds are generally recommended for smaller cities. These bonds are payable by owners of taxable real property in the City through their property taxes. The amount is based on 'assessed value' of the property, not 'market value.'
- The annual cost of debt repayment will be between \$18 and \$43 per \$100,000 of assessed value. Example: if a typical single-family home has an assessed value of \$300,000, the annual cost of debt repayment would be between \$59 and \$129 per year. The specific amount would be fixed year-to-year.
- For the measure to pass, it takes two-thirds approval of voters casting ballots. Public outreach is essential.
- Pre-Election Estimated Costs: between \$18,000 to \$20,000. If the measure passes, postelection estimated costs would be approximately \$160,000, payable from bond proceeds.

Mayor Julian said, "This whole process...we've been meeting two, three times a week. A lot going on. We don't know the exact amount yet...it's going to be over, but we don't know now." Mr. Bodem said, "Bids will give actual amount."

The mayor said, "Public outreach...the City can't be involved. The City's not allowed to use city resources to support bond advocacy. With EDA, feds...have to have monies upfront for them to give us monies. If we wait, it will hinder us and not get the \$5 million."

Mr. Bodem added "If this passed, it would be a community project, the revitalization of the Royal Theatre. It would draw people to it – anchor for the community...a cultural benefit."

Mayor Julian asked, "Legal counsel and municipal advisor for \$15,000. What do we get for that?" Mr. Gortler said, "Financial consultant perspective. Impact on taxpayers. Analyzing distribution — who will pay how much. Review all documents." Mr. Wawrzniak said, "Legal counsel. Coming back for two (2) meetings. Resolution and ordinance to place on ballot. Assist City...federal tax law side. Successor owned property. Make sure tax emption rule is followed.

Mr. Bodem then said, "Downscale building? Why not build for community; retain old but add...intrinsically put together. This is a way to access dollars quicker and make sure the project gets finished.

Requests to Speak

Mr. Bodem read an email from Shirley Boydstun received on 3/25/24: "I strongly urge the Council and any residents speaking tonight to carefully assess the proposal to contract with 2 firms to raise more funds toward the Royal theater revitalization. IF the bond proposal is agreed upon that means \$50 to \$70 dollars annually on homeowner's property tax bills for the next 30 years...the usual life of a bond issue.

Spending 15 to 20 thousand to raise another 5 or more million for the theater project does not pencil out for property owners.

The project has 10 million plus in hand now, so why not proceed in phases as has been done with Leroy park and other projects. The ten million plus will allow for upgrades, proper bathrooms, and dressing rooms for performers. The theater will then be ready to be rented for general use: speaker presentations, musical performances, dance programs, school graduations and many other uses.

The money from rentals-or maybe even a lease-will add to the building funds for the 2^{nd} phase: the 3-story building. And that, too, also requires a careful look. Allan Hancock College has a well-planned and accredited film program for college age and adults. Why try to duplicate that here? And what is the need for a 'large kitchen'?

Lompoc City has a theater similar in size and age as the Royal. Citizens there have been working for ten plus years to bring it to life. We should do the same. Fundraise to augment the rental revenue before going into further debt on a long-range project when in a shorter time the theater can be ready for use if slightly redesigned for restoration in a shorter span of time. Shirley Boydstun."

Ms. Frances Romero: "Welcome to Council Member Furness. I have some random comments: I've not seen that you've done any voter sentiment survey. You have some time to do that between now and June. You have an opportunity to have a consultant at some cost do a random survey to see how homeowners, registered in both parties, to see how they look at a bond measure. Maybe you'll be looking at low numbers...that might give you some pause. Really high numbers, then 'yeah.' Public outreach...that's going to be a citizen driven exercise.

The fixed fee for \$10,000. Knowing what attorneys' costs are, if they charge \$500 per hour...that's 20 hours – hopefully, that's enough to get their work done. Hopefully, there won't be any surprised costs coming up.

I do agree with some of the things that Shirley (Boydstun) said. And I want to thank Todd for providing me with some information earlier today. There has to always be a back-up plan. So, what is the back-up plan? Maybe it is having to scale back some of the more expensive amenities.

Looking forward to seeing how this all turns out. I know that when you look at bond measures by themselves, it's only \$10 a month. But then you look at the list of bond measures on your property tax bill...most of us happily voted for most of what's on there. Costs are not coming down...incomes are not rising...inflation doesn't seem to be moving much either. I recommend doing some sort of voter sentiment. I can recommend a couple of consultants regarding that...they could do a survey in probably less than a month. You'd at least have some information gauging community support."

Before the next speaker was called to the podium, Mayor Julian asked, "Value added...do we need certain things rights away? What do we need right now? EDA monies is for the actual theatre, itself. Electrical, HVAC system – that second portion is needed. That's needed to house HVAC and all the

mechanical systems. Can't do one without the other. The third and fourth story — can't eliminate...part of the mechanical system. You just can't eliminate that."

<u>Mr. Albert Nunez</u>: "Voter sentiment -I'll give you some right now from homeowners and residents. But I want to give you some of my background. I had a career in marketing communications. I have experience in theatre...I've written and directed plays...I definitely have an affinity for the arts. But I don't believe that 'if you build it, they will come.'

I agree with what Ms. Romero said about needing more data. You've talked at the 30,000 feet level...bring it down to the pedestrian level. Seniors have to play hopscotch with their money. \$54 - \$120 - not much, but for seniors, houses are paid off – this will be more dollars out of their budget. I just wanted to bring this down to the pedestrian level – now my vote is 'No.' To make me change my mind, I have to know what's the value for the community. Long-range and short-range?"

Mayor Julian said, "\$10 million...you don't get that every day. Will come in more than \$10 million. It's projected to be maybe \$3 million to \$5 million. Fundraisers won't do it." CM Robles asked, "What is the percentage of Andrew Goodwin's plan now? How much are they finished?" Mr. Bodem said, "About 100% of the plans are completed but some changes are being asked for now – drawings are mostly complete."

The mayor said, "Amphitheater – eliminate that but not sure of the cost." CM Robles said, "Keep art deco and tie that all in – work and costs are crazy." Mayor Julian added, "EDA – if you don't have the money in the bank, you lose it and the project."

CM Costa, Jr. said, "As a homeowner, we just passed two (2) bonds to build the new school. A lot of people in our community are on fixed income. This kind of thing will affect those people. The Royal Theatre is a historical landmark. Would love to see it up and running, but we need to start small. We all look at the big picture, and it all looks nice. It all comes down to money. We don't have any tax revenue. It's very limited to what we can do. Would be nice to do in phases like Le Roy Park. The commercial land at Pasadera – don't know when that's going to happen but that would bring revenue so we wouldn't have people pay for a bond measure. Frances (Romero) said a good thing – a survey. We need voter input. I'll say that when they passed the last two (2) bond measures for the school, I wasn't for it. I'm not afraid to say it. They didn't change anything from what they told us two (2) years prior when we did those measures. We need to get the voters input on all of this for another bond measure to be added to their property taxes for thirty years."

CM Hernandez said, "Difficult decision. One year to raise \$2 million." CM Furness said, "I appreciate everyone's perspective. Depending on final numbers on what homeowners will have to pay in their property taxes. It could break down to \$10 - \$20 per month. That may not be a lot to some, but it can be a lot to some people. And I respect that and understand that. If we all come together and pay...however you look at it, we pay a small amount in the scheme of the Royal Theatre project, we can get this thing going. It's like the community coming together to finish this project. That's my thought but I do believe there are other valid ways to look at this."

Mayor Julian said, "This is one option we're looking at right now. Another option...is there a donor out there who can kick in \$3 million?" CM Robles said, "Just to correct...it's the assessed value of the home, not the market value." Mr. Bodem added, "People buying in the upper priced levels...they'd be paying the lion's share. If you put the theatre and get it running, it could be an incremental...the more economic activity will start. Then the 18 acres will be developed at Pasadera. In ten years, you'll be seeing these little pieces that will provide economic development in the community that will help drive everyone's lives."

CM Robles said, "An old Greek proverb says that 'A society grows great when people plant tress for shade they will never sit under'."

Mayor Julian asked what the wish of the Council was. City Attorney Sinco said, "We would only be Looking to authorize the project to proceed but can change down the road. Do a survey – by June, make a decision at that time. Do we want to consider tonight or not?" The mayor said, "What do we lose by not doing this? I appreciate CM costa's point of view on this. The Royal Theatre is the heart of the City. We're asking Allan Hancock College to be part of this, too. If we don't do it, who will?" CM Robles said, "I support to go to the voters."

Motion was made by Council Member Furness and seconded by Council Member Robles to approve Resolution No. 2024-26. Roll Call: 4 No: 1 Costa, Jr. 4-1 Motion passed.

14. Renaming of Central Park.

Written report: Annis Barajas, Recreation Services Manager

<u>Recommendation</u>: The Recreation and Parks Commission recommends that the City Council adopt Resolution No. 2024-27 renaming of Central Park to Las Mujeres Park and review the proposed process for selecting a recipient of Las Mujeres Park Women of the Year award and inscribing her name on a perpetual memorial plaque in the park.

Ms. Barajas gave a brief background on this item: The idea of renaming Central Park came about during the time that streets in the Pasadera development were going to be named after Guadalupe veterans. The Recreation and Parks Commission ("Commission") developed the idea of renaming Central Park after something significant to Guadalupe. Commissioner Emily Dreiling mentioned that March is Women's History month and recommended to the Commission that Central Park be renamed after a Guadalupe female of significance. The Commission ultimately decided that the park would be renamed "Las Mujeres" Park but to still recognize an individual female of the year to be nominated by the community for recognition each year.

Ms. Barajas then discussed the selection process for the "Las Mujeres Park Woman of the Year" award. (Criteria for nominations will be determined at a later date.) A nomination period from August 26th and ending in mid-October would be open to accept nominations. The Recreation Services Manager would then submit a staff report to the Commission with all the nominations. Two (2) Commission meetings would be held to narrow down the nominations to three (3) candidates.

The Recreation Services Manager will submit a staff report to the City Council in one of the meetings in January with the top three (3) Commission recommended nominees. Once the City Council makes a final decision, the Recreation Services Manager would inform the individual of their selection as the 'Las Mujeres Park Woman of the Year.' A perpetual memorial plaque would be procured, and each year, thereafter, a new honoree would be added to the plaque.

A celebration would occur with a ceremony celebrating the honoree annually on March 8th, a day recognized as International Women's Day. This is a global day celebrating the social, economic, cultural, and political achievements of women, as well as marking a call to action for accelerating women's equality. A QR code containing the biography of the honoree would be located at the bottom of the plaque.

If the City Council approves the reaming of the park as well as the selection process, the Recreation Department will solicit local organizations to volunteer their time and resources to raise funds to cover the cost of the plaque, installation, and ongoing maintenance.

Requests to Speak

Mayor Julian read an email received from Shirley Boydstun on 3/25: "The renaming of now CENTRAL PARK needs much thought before a decision is made. Something significant as the Agenda narrative says that would not be another person's name. We have O'Connell and Leroy parks already. The new name should be something significant yet generic and pertinent.

Las Mujeres may be viewed as sexist (no males) or even racist in today's culture. Naming of an annual Woman of Importance is to be commended but not in conjunction with the park. A park has been in that area since at least 1926 when the little jail was built there, and the prior elevated tank was completed in 1928. It will be between 2026 and 2028 when the park upgrades are completed. How about the name of CENTENNIAL Park which will note an era in the City's growth and citizen involvement. Shirley Boydstun."

Ms. Emily Dreiling: I am a Recreation & Parks Commissioner. There are two (2) others here tonight. Our Commission wants a sense of pride...there is one street in Pasadera named for a woman. There are two (2) state parks and one (1) national park named after women. The name will be inclusive and not a name after only one person. The name of the honored individual will change each year. We want to put Guadalupe on the map, include representation. August is 'Women Equality Month.' This would be a good example and would showcase fifty percent of our population not recognized in our streets and parks."

Ms. Frances Romero: In 70 years, I am the only female mayor of Guadalupe. I serve on a national organization, a bi-partisan group. I'm torn on this as a former Parks Commissioner. A nice improvement would be to name it 'Centennial Park.' A gazebo would be nice. Some streets could be renamed over time. A non-specific name — it's not for women — the park is for everyone. Look at other ways to recognize women in Guadalupe."

Mr. Albert Nunez: One of the ideas was to have a central gathering place – Central Park. Le Roy Park – the deed said it would be used for town activities. I'm also torn – as a member of the Historical Society and the Cemetery. There's a great tapestry here – behind every great man is a great woman.

Take Petra Concepcion. She was in her 80s serving lunch at the Senior Center. To use the park to honor them – we can do better. We can have an event every year to honor women at the park. Rename it 'Guadalupe Park' – it's for everyone. But honoring women in Guadalupe, past, present, and future should occur all the time."

<u>Mr. Michael Jimenez</u>: I looked at the opposition to this, especially the email. I take exception to two things: that this is sexist or racist. We live in a male-dominated world. Let's face it. Anytime we can think out of the box and honor women, we should do it. As for this being racist, then let's change a number of park names then that have Spanish name. This just doesn't resonate for me."

CM Hernandez said, "As a woman of color, I grew up here in Guadalupe. My mother told me not to speak Spanish because I'd be excluded from things at school. It's really important to empower girls, that they're at the table to help strengthen the economy. This is important."

CM Costa, Jr. said, "I look at the street names. They're last names, not a specific gender. Jack O'Connell and Le Roy Park – for years. Tognazzini Park. Paco Park, named after Paco Pereyra. There are a lot of women in our community that have done great things. Have an annual event to honor them. Central or Centennial Park is better."

CM Robles said, "I have no problem with Las Mujeres Park. We live in a society that's male dominated. A lot of names out there are male."

Ms. Hannah Sanchez added, "I heard a lot said that it's not inclusive to call it 'Las Mujeres.' How is Le Roy Park, O'Connell Park, Paco Park being inclusive of others? As Shirley said, are we going to be specific about this? The idea behind this was to be inclusive, to include females. Each year in March, we'd pick someone and have a women's day festival at the park."

Mayor Julian added, "There's a picture of a softball team from the 1930s. Dorothy Oliveira, Pete Amido, Betty Silva all played on the softball team. They played against the WACS at Camp Cook and beat them. It's time for us to show that we do respect women because we do. Is there a motion?"

Motion was made by Council Member Hernandez and seconded by Council Member Furness to approve Resolution No. 2024-27 renaming Central Park to Las Mujeres Park. Roll Call: Ayes: 5 5-0 Motion passed.

Ms. Sanchez said, "The first one should be Amelia Villegas." Ms. Villegas politely declined.

15. FUTURE AGENDA ITEMS

No additional items were added.

CM Costa, Jr.:

I toured the wastewater treatment plant. I encourage other council members to talk with Dave Miklas, Supervisor, to see the entire process. It was interesting to see. There are things that need upgrading. The last process of water that goes out to the land, (effluent), is very clear. I was amazed at that

There will also be a fundraiser for STEAM for McKenzie. It will be at the Guadalupe Social Club on Saturday, March 30^{th} , from 12:00 p.m. to 5:00 p.m. The science teacher at McKenzie uses the monies for the program to fund field trips to Los Angeles.

CM Hernandez:

On Saturday, 3/30, there will be the mobile Farmers' Market, from 1:00 p.m. to 3:00 p.m.

Kiwanis is having a fundraiser at McKenzie on Friday, 3/29, from 4:00 p.m. to 7:00 p.m.

There will be a fashion show in April.

CM Robles:

Bobcat wrestling. The number of kids participating have exceeded last year's number, 25. This year it's 59. There are a lot of girls coming out to wrestle. They show a lot of hard work and discipline. We're promoting higher education...we're mandating for the school program, a minimum of 2.0 GPA, no "F" grades, no "U" markings for behavior. On 4/13, we will be at Mesa Middle School – all girls and some novice boys. We also will have three (3) duals here at City Hall.

SUBJECT: Second reading of amendments to the subdivision ordinance, Chapter 17

EXECUTIVE SUMMARY:

A first reading of the subdivision ordinance amendment took place on March 26, 2024. The amendment included changes to the lot size and lot width for single-family, R-1 lots within the city. These changes are being recommended due to revisions to the 2042 General Plan and subsequent updates to the zoning ordinance. The amendment was approved on a 5-0 vote.

The attached ordinance represents a clean version of Section 17.030 which contains the two amendments. Once adopted, these changes will allow an existing lot split to be recorded in full compliance with the subdivision ordinance.

If approved this evening, Ordinance No. 2024-517 would go into effect on May 9, 2024.

RECOMMENDATION:

It is recommended that the City Council:

1) Adopt the second reading of Ordinance No. 2024-517 amending Chapter 17.32.030 of the Municipal Code on consent.

FISCAL IMPACT:

There should be no fiscal impacts as a result of this ordinance amendment.

BACKGROUND:

Ordinance No. 2024-517 amending Chapter 17 of the Municipal Code was introduced by the City Council at its regular meeting on March 26, 2024.

ORDINANCE NO. 2024-517

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GUADALUPE, CALIFORNIA, TO AMEND THE SUBDIVISION ORDINANCE (SECTION 17.32.030.A OF THE GUADALUPE MUNICIPAL CODE)

The City Council of the City of Guadalupe, State of California, does ordain as follows:

WHEREAS, the City Council recognizes that the City's subdivision ordinance was adopted over 50 years ago in 1974, and that many sections of the ordinance are outdated, and do not reflect mandatory State regulations that have been enacted over the years; and

WHEREAS, the state of California has made a number of changes to housing law in order to increase housing stock in all jurisdictions; and

WHEREAS, staff is systematically reviewing and amending the subdivision ordinance to ensure that the final version reflects the desire of City Council to provide the most accurate document to describe and regulate development within the City; and

WHEREAS, public notice pursuant to Government Code section 65090 was posted on or about March 15, 2024.

WHEREAS, on March 26, 2024, by a unanimous vote of the City Council, the ordinance amendment was introduced and the first reading was waived.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GUADALUPE DOES ORDAIN AS FOLLOWS:

SECTION 1. Section 17.32.030.A of the Guadalupe Municipal Code is hereby amended as follows:

Section 17.32.030 Lot area, depth and access to street.

A. The minimum area of lots shall be 3,630 square feet, with a minimum width of 45 feet, except in cases of R-1-M and planned unit developments.

- B. Lots having an average depth of more than 3 times the average width shall not be approved.
- C. All lots shall have vehicular access to a street. (Ord. 142 Art. 3 §3, 1974; Ord. 86-264)

This Ordinance has been reviewed for compliance with the California Environmental Quality Act (CEQA), and the CEQA guidelines, and has been found to be exempt pursuant to §15306 of the CEQA Guidelines (Information Collection) because it does not have the potential to create a physical environmental effect.

SECTION 3.

The City Council declares that each section, subsection, paragraph, subparagraph, sentence, clause, and phrase of this Ordinance is severable and independent of every other section, subsection, paragraph, subparagraph, sentence, clause, and phrase of this Ordinance. If any section, subsection, paragraph, subparagraph, sentence, clause, or phrase of this Ordinance is held invalid, the City Council declares it would have adopted the remaining provisions of this Ordinance irrespective of the portion held invalid, and further declares its express intent that the remaining portions of this Ordinance should remain in effect after the invalid portion has been eliminated.

SECTION 4.

The City Clerk is hereby authorized to make minor changes herein to address clerical errors, so long as substantial conformance of the intent of this document is maintained. In doing so, the City Clerk shall consult with the City Administrator and City Attorney concerning any changes deemed necessary.

SUBJECT: Approving of the professional services agreements with Jones Hall, A Professional

Law Corporation, and Wulff, Hansen & Co. to assist with bond financing for the

Guadalupe Royal Theater Renovation Project.

RECOMMENDATION:

It is recommended that the City Council adopt Resolution No. 2024-28 approving the professional services agreements with Jones Hall, A Professional Law Corporation as bond counsel and Wulff, Hansen & Co. as municipal advisor, to assist with bond financing for the Guadalupe Royal Theater Renovation Project.

BACKGROUND:

Constructed in 1939, the Royal Theater operated as an active movie theater until closed in 1989. Following its closure, the building was intermittently used for a variety of purposes including a performing arts theater and public meeting space until 2011. In 2011 it was red tagged due to a minor interior electrical fire. The former Redevelopment Agency of the City of Guadalupe (RDA) purchased the property in 2001, and with the dissolution of the RDA ownership, transferred to the Successor Agency (SA) in 2012. In accordance with state law, the SA adopted a Long-Range Property Management Plan (LRPMP) to guide the disposition of the property. The LRPMP stipulates that the theater should be transferred to the City and ultimately the theater should be renovated as some form of Public Performing Arts Center.

The Royal Theater Renovation Project is being undertaken by the City to (1) reconstruct, rehabilitate, and renovate, to historic standards, Royal Theater and (2) construct an additional, connected 3-story performing arts center, amphitheater, and community plaza. The Royal Theater Renovation Project is an essential project of public infrastructure for the City as it is part of the basic, underlying features of the City's physical landscape, community identity and organization.

Over the course of the last five (5) years, the City has diligently worked to raise the vast majority of funding needed for the Royal Theater Renovation Project. In total, the City has secured or is in the process of securing more than \$10 million in grants and other financing. These consist of the following anticipated sources/amounts:

- Economic Development Administration (EDA) grant (\$4.8 million)
- California Arts Council State Legislative Passthrough Funding (\$5.0 million)
- Historic Tax Credit (HTC) investments (approximately \$0.8 0.9 million)

Final cost estimates are not yet available, but the City believes an additional approximately \$3.0 million (and potentially up to \$5.0 million) is required to ensure the project can be completed as designed. The timeline for obtaining funding is running short, as the \$4.8 million EDA grant will expire if construction is not started by March 2024.

DISCUSSION:

After exhaustively exploring all options, City staff reached the conclusion that placing a bond measure on the November 2024 ballot now represents the best option to ensure the funding for the project is in place in a timely manner. To put a bond measure on the November 2024, specialized consultants are required. At its last meeting on March 26, 2024, the City Council received a presentation concerning the possibility of placing a bond on the November 2024 ballot, and approved hiring Jones Hall, A Professional Law Corporation as bond counsel to the City, and Wulff, Hansen & Co., as municipal advisor to the City, analyzing tax rates, bond interest rates and related matters. These firms provided the following "not to exceed" fee proposals to the City: Jones Hall (\$10,000) and Wulff Hansen & Co. (\$5,000). In addition to these consultants, the Santa Barbara County elections department would charge the City an additional fee to place the measure on the November 2024 ballot; final details are to be confirmed, but the City believes the cost would not exceed \$5,000.

Although the City Council has already approved the hiring of these two firms, it needs to approve the professional services agreement with Jones Hall pursuant to Guadalupe Municipal Code section 4.04.090.A, which requires the City Council to award any contract for legal services. The agreement with Jones Hall is attached hereto as **Attachment 1**. The agreement with Wulff, Hansen & Co. is attached as **Attachment 2**. Although the Guadalupe Municipal Code does not require the agreement with Wulff, Hansen & Co. to be approved by the City Council, it is being presented to the Council for approval at this time since it is related to the legal services agreement with Jones Hall.

FISCAL IMPACT:

The current total cost of hiring the financing team and placing the measure on the November 2024 is estimated at \$20,000. These funds would initially be paid from the City's Fiscal Year 24/25 budget. If the measure fails, these costs would be borne by the General Fund. If the measure passes, the City could consider reimbursing the General Fund from bond proceeds.

AGREEMENT FOR LEGAL SERVICES

BETWEEN THE CITY OF GUADALUPE AND JONES HALL, A PROFESSIONAL LAW CORPORATION FOR BOND COUNSEL SERVICES IN CONNECTION WITH GENERAL OBLIGATION BOND ELECTION

This AGREEMENT FOR LEGAL SERVICES is entered into April 9, 2024, between the CITY OF GUADALUPE, a California municipal corporation and general law city (the "Client") and JONES HALL, A PROFESSIONAL LAW CORPORATION ("Attorneys").

WITNESSETH:

WHEREAS, the Client is considering placing a General Obligation Bond measure on the November 2024 ballot to raise funds for the Guadalupe Royal Theater Renovation Project (the "Project"); and

WHEREAS, the Client requires the advice and assistance of special legal counsel with expertise in drafting resolutions and related documents required to place a General Obligation Bond measure on the November 2024 ballot and, if successful, issue General Obligation Bonds in 2025 or thereafter (the "Bonds"); and

WHEREAS, Attorneys are qualified by training and experience to perform the services, and Attorneys are willing to provide such services to Client.

NOW, THEREFORE, THE PARTIES HERETO MUTUALLY AGREE AS FOLLOWS:

Section 1. Attorney-Client Relationship. Upon execution of this Agreement, the Client will be Attorneys' client and an attorney-client relationship will exist between Client and Attorneys. Attorneys assume that all other parties will retain such counsel, as they deem necessary and appropriate to represent their interests in this transaction. Attorneys further assume that all other parties understand that in this transaction Attorneys represent only the Client, Attorneys are not counsel to any other party, and Attorneys are not acting as an intermediary among the parties. Attorneys' services are limited to those contracted for in this Agreement; the Client's execution of this Agreement will constitute an acknowledgment of those limitations.

<u>Section 2</u>. <u>Scope of Engagement as Special Legal Counsel</u>. Attorneys shall perform all of the following services as special legal counsel to the Client related to the Bond election:

- a. Preparation of all legal proceedings for the lawful calling of a Bond election by the Client in November 2024, including preparation of resolutions and an ordinance calling the Bond election, and advising the Client during the election period with respect to appropriate informational and non-partisan activities.
- b. Advising the Client, from the time Attorneys are hired as Bond Counsel until the Bonds are issued, as to compliance with federal tax law as required to ensure that interest on the Bonds (should the Bonds be issued in the future) is exempt from federal income taxation.

c. Such other and further services as are normally performed by bond counsel in connection with similar Bond measures.

Section 3. [Reserved].

Section 4. Excluded Services. Our duties in this engagement are limited to those expressly set forth above in Section 2, except as expressly set forth in a written amendment to this Agreement, which may include expanding the scope of services (assuming a successful Bond election) for Attorneys to perform additional legal services related to the actual issuance and sale of the authorized Bonds. Among other things, our duties do not include:

- a. Preparing requests for tax rulings from the Internal Revenue Service, or "no-action" letters from the Securities and Exchange Commission.
- b. Preparing blue sky or investment surveys with respect to the Bonds, or performing research regarding the Client's past compliance with regard to prior undertakings pursuant to Securities and Exchange Commission Rule 15c2-12, if any.
- c. Drafting state Constitutional or statutory amendments.
- d. Pursuing test cases or any other litigation, such as validation actions, or legal challenges which arise during the election proceedings.
- e. Making an investigation or expressing any view as to the creditworthiness of the Client or the Bonds.
- f. Representing the Client in Internal Revenue Service examinations, audits or inquiries, or Securities and Exchange Commission investigations.
- g. Reviewing or opining on the business terms of, validity, or federal tax consequences of any derivative financial products, such as an interest rate swap agreement, that the Client may choose to enter into in connection with the issuance of the Bonds, unless the Client and Attorneys agree on the terms of such review and compensation for such review.
- h. Providing advice on financial structuring, market timing or size of the proposed issue(s) of Bonds, other than with respect to legal considerations.
- Reviewing, advising or opining on service contracts relating to bond projects such as architect contracts, construction contracts or the methods of obtaining said services, or providing advice or opining on or reviewing applications relating to federal or state grant programs or other matching fund programs.

<u>Section 5</u>. <u>Conflicts; Prospective Consent</u>. Attorneys' sole practice focus is municipal finance and, for the purpose of avoiding potential legal conflicts, Attorneys do not represent developers. However, Attorneys represent many political subdivisions, investment banking firms and financial advisory firms. It is possible that during the time that Attorneys are representing the Client, one or more of Attorneys' present or future clients will have transactions with the

Client. It is also possible that Attorneys may be asked to represent, in an unrelated matter, one or more of the investment banking firms or financial advisory firms involved in the issuance of the Bonds. Attorneys do not believe such representation, if it occurs, will adversely affect Attorneys' ability to represent you as provided in this Agreement, either because such matters will be sufficiently different from the issuance of the Bonds so as to make such representations not adverse to our representation of you, or because the potential for such adversity is remote or minor and outweighed by the consideration that it is unlikely that advice given to the other client will be relevant to any aspect of the issuance of the Bonds. Execution of this Agreement will signify the Client's consent to Attorneys' representation of others consistent with the circumstances described in this paragraph. Notwithstanding the foregoing, and in order to provide greater assurances to the Client about potential future conflicts, Attorneys hereby covenant that they will not, in the course of any representation of present or future clients in transactions with the Client, take any position adverse to the Client with respect to the Bonds.

- <u>Section 6.</u> <u>Compensation</u>. The following fees apply to the legal services rendered hereunder:
 - (a) <u>Election Proceedings</u>. For the services of Attorneys performed in connection with calling a Bond election and providing legal advice during the period leading up and until the election as provided in Section 2, Client shall pay Attorneys a flat fee of \$10,000. Payment shall be due following the results of the November 2024 election, regardless of the success of the measure.
 - (b) <u>Bond Issuance</u>. As noted above, should the Bond election be successful, this Agreement may be amended to expand the scope of services and compensation to include services related to a Bond issuance.

The fees identified herein are not set by law but are negotiable between Attorneys and the Client.

Section 7. Responsibilities of the Client.

- (a) <u>General</u>. The Client will cooperate with Attorneys and furnish Attorneys with certified copies of all proceedings taken by the Client, or otherwise deemed necessary by Attorneys related to their scope of work.
- (b) <u>Federal Tax Law-Related Responsibilities</u>. The Code imposes various restrictions, conditions and requirements relating to the exclusion from gross income for federal income tax purposes of interest on obligations such as the Bonds. The Client understands these items would apply past issuance of any series of Bonds.
- <u>Section 8</u>. <u>Independent Contractor</u>. Attorneys will act as an independent contractor in performing the services required under this Agreement, and under no circumstances shall Attorneys be considered an agent, partner, or employee of the Client.
- <u>Section 9</u>. <u>Assignment</u>. Attorneys may not assign their rights or delegate their obligations under this Agreement, in whole or in part, except with the prior written consent of the Client.

Section 10. Termination of Agreement.

- (a) <u>Termination by Client</u>. This Agreement may be terminated at any time by the Client with or without cause upon written notice to Attorneys.
- (b) <u>Termination by Attorneys</u>. This Agreement may be terminated by Attorneys upon 15 days' written notice to Client if Client fails to follow written legal advice given by Attorneys.
- (c) <u>Termination Upon Issuance of Bonds.</u> This Agreement shall terminate upon the issuance of the Bonds.
- (d) <u>Consequences of Termination</u>. In the event of termination, all finished and unfinished documents shall at the option of the Client become its property and shall be delivered to the Client by Attorneys.

This is an Agreement (AGREEMENT) between the City of Guadalupe (CLIENT) and Wulff, Hansen & Co. (MUNICIPAL ADVISOR or ADVISOR or MA) a registered municipal advisory firm. The purpose of the AGREEMENT is to provide a framework allowing MUNICIPAL ADVISOR to provide municipal advisory services (SERVICES) to CLIENT from time to time as may be mutually agreed upon by both parties. All such SERVICES to be delivered under this Agreement will be specifically described in an Addendum to the AGREEMENT accepted by both parties, and no services will be provided in the absence of such an Addendum. The terms and conditions of this Agreement are set forth below. CLIENT understands and acknowledges that any information or services provided by ADVISOR pursuant to an Addendum to this Agreement are for the purpose of serving as Municipal Advisor to CLIENT and not as an Underwriter or otherwise facilitating the placement of municipal securities issued by CLIENT.

This AGREEMENT also contains various disclosures and other information required under MSRB Rule G-42 and, with its Addenda, will serve as written documentation of certain specific terms, disclosures and other items of information relating to our relationship as of the date this AGREEMENT is signed by ADVISOR. If this information materially changes during the relationship any such change will be described in writing and delivered to you.

1. Scope of Services.

(a) Services to be provided.

From time to time CLIENT may request that ADVISOR provide municipal advisory services relating to a specific project or projects. The scope of any such services, any limitations thereon, any compensation to be earned by ADVISOR in connection with their delivery, and any conflicts of interest (other than those disclosed in this AGREEMENT) that ADVISOR may have in connection with such services will be described in an Addendum to this AGREEMENT. No services which are not so described and documented in an Addendum will be provided by ADVISOR to CLIENT.

(b) Limitations on Scope of Services

Where an Addendum to this Agreement describes the scope of services to be provided under that Addendum, any limitations on such scope in addition to those included in this Agreement will be described in that Addendum.

Unless otherwise specifically provided in an Addendum to this Agreement, ADVISOR is not responsible for preparing any preliminary or final official statement, or for certifying as to the accuracy or completeness of any preliminary or final official statement, other than with respect to any information about Municipal Advisor provided by Municipal Advisor for inclusion in such documents. In addition, ADVISOR will not provide any of the following services in connection with any engagement pursuant to this Agreement or any associated Addenda:

- a) Legal services of any kind;
- b) Assistance to CLIENT with regard to CLIENT's responsibilities under the federal securities laws and regulations relating to initial or continuing disclosure in connection with municipal securities, inclusive of the Securities Act of 1933 and Rule 10b-5 promulgated under the Securities Exchange Act of 1934. Such services will be provided only if ADVISOR is explicitly engaged by CLIENT in a separate contract unrelated to this Agreement or any Addenda thereto.
- c) Engineering services of any kind;

- d) Special Tax Rate Consulting
- e) Absorption Analysis or the review thereof;
- f) Feasibility Studies or the review thereof
- g) Fiscal Consulting;
- h) Underwriting or placement agent services;
- i) Accounting services;

CLIENT acknowledges its responsibility with respect to compliance with federal securities laws and represents its intention to comply in all respects with such laws. CLIENT acknowledges and understands that state and federal laws relating to disclosure in connection with municipal securities may apply to the CLIENT and that the failure of ADVISOR to advise CLIENT respecting these laws shall not constitute a breach by ADVISOR of any of its duties and responsibilities under this Agreement.

CLIENT acknowledges and accepts that members of Municipal Advisor's staff, for regulatory compliance policy reasons, are not permitted to and will not employ SMS text messaging, social media applications such as WhatsApp, or any other form of electronic communication or messaging other than standard email and telephonic voice communications, and CLIENT agrees that it will not attempt to use such means of communication in the course of its business with Municipal Advisor. Should CLIENT wish to use Zoom for realtime electronic communications with Municipal Advisor, CLIENT agrees that it will not attempt to use or engage with Zoom's 'chat' function, which is an electronic messaging system that Advisor's staff is not permitted to employ.

2. Municipal Advisor's Regulatory Duties When Advising CLIENT.

MSRB Rule G-42 requires that Municipal Advisor make a reasonable inquiry as to the facts that are relevant to CLIENT's determination whether to proceed with a course of action or that form the basis for any advice provided by MA to CLIENT. The rule also requires that MA undertake a reasonable investigation to determine that it is not basing any recommendation on materially inaccurate or incomplete information. Municipal Advisor is also required under the rule to use reasonable diligence to know the essential facts about CLIENT and the authority of each person acting on CLIENT's behalf.

Accordingly, MA will seek CLIENT's assistance and cooperation, and the assistance and cooperation of CLIENT's agents, with the carrying out by Municipal Advisor of these regulatory duties, including providing to Municipal Advisor accurate and complete information and reasonable access to relevant documents, other information and personnel needed to fulfill such duties. In addition, to the extent CLIENT seeks to have MA provide advice with regard to any recommendation made by a third party, MA requests that CLIENT provide to MA written direction to do so as well as any information it has received from such third party relating to its recommendation.

3. Term.

This AGREEMENT shall become effective upon acceptance by both parties and shall terminate **on March 28, 2025** unless terminated earlier by one of the parties. Either party may terminate this AGREEMENT upon thirty days written notice to the other party or as may be mutually agreed by both parties. ADVISOR's engagement to provide municipal advice on a specific project or projects described in an Addendum to this document shall terminate as described in that Addendum.

4. Compensation.

The form and basis of any compensation for any of Municipal Advisor's services provided or expenses incurred pursuant to an Addendum to this AGREEMENT will be as described in that Addendum.

5. <u>Limitation of Liability.</u>

In the absence of willful misconduct, bad faith, gross negligence or reckless disregard of obligations or duties hereunder on the part of Municipal Advisor or any of its associated persons, Municipal Advisor and its associated persons shall have no liability to CLIENT for any act or omission in the course of, or connected with, rendering services hereunder, or for any error of judgment or mistake of law, or for any loss arising out of any issuance of municipal securities, any municipal financial product or any other investment, or for any financial or other damages resulting

from CLIENT's election to act or not to act, as the case may be, contrary to any advice or recommendation provided by Municipal Advisor to CLIENT. No recourse shall be had against Municipal Advisor for loss, damage, liability, cost or expense (whether direct, indirect or consequential) of CLIENT arising out of or in defending, prosecuting, negotiating or responding to any inquiry, questionnaire, audit, suit, action, or other proceeding brought or received from the Internal Revenue Service in connection with any Issue or otherwise relating to the tax treatment of any Issue, or in connection with any opinion or certificate rendered by counsel or any other party. Notwithstanding the foregoing, nothing contained in this paragraph or elsewhere in this Agreement shall constitute a waiver by CLIENT of any of its legal rights under applicable U.S. federal securities laws or any other laws whose applicability is not permitted to be contractually waived nor shall it constitute a waiver or diminution of Municipal Advisor's fiduciary duty to CLIENT under Section 15B(c)(1) of the Securities Exchange Act of 1934, as amended, and the rules thereunder.

6. Required Disclosures.

MSRB Rule G-42 requires that MUNICIPAL ADVISOR provide CLIENT with the following disclosures of material conflicts of interest and of information regarding certain legal events and disciplinary history.

(a) **Disclosures of Conflicts of Interest.** MSRB Rule G-42 requires that municipal advisors provide to their clients disclosures relating to any actual or potential material conflicts of interest, including certain categories of potential conflicts of interest identified in Rule G-42, if applicable. If no such material conflicts of interest are known to exist based on the exercise of reasonable diligence by the municipal advisor, municipal advisors are required to provide a written statement to that effect.

Accordingly, any material conflicts of interest known to MUNICIPAL ADVISOR in connection with the Scope of Services are disclosed below, including those conflicts applying to various forms of compensation which are described in a document attached to this AGREEMENT. We believe that these conflicts are mitigated by our duties to CLIENT as assigned to us under Federal and State laws and regulations and the rules of the Municipal Securities Rulemaking Board. In addition, because MUNICIPAL ADVISOR is a broker-dealer with significant business and economic interests due to the nature of its overall business, the success and profitability of MUNICIPAL ADVISOR is not dependent on maximizing short-term revenue generated from individualized recommendations to its clients but instead is dependent on long-term profitability built on a foundation of integrity, quality of service and strict adherence to its fiduciary duty where such duty exists. Furthermore, MUNICIPAL ADVISOR's municipal advisory supervisory structure, leveraging our long-standing and comprehensive broker-dealer supervisory processes and practices, provides strong safeguards against individual representatives of MUNICIPAL ADVISOR potentially departing from their regulatory duties due to personal interests.

Other Municipal Advisor or Underwriting Relationships.

MUNICIPAL ADVISOR serves a wide variety of other clients that may from time to time have interests that could have a direct or indirect impact on the interests of CLIENT. For example, MUNICIPAL ADVISOR and/or its Municipal Advisor Representatives provide municipal advice to other municipal advisory clients and, in such cases, owes a regulatory duty to such other clients just as it does to CLIENT under this Agreement. These other clients may, from time to time and depending on the specific circumstances, have competing interests, such as accessing the new issue market with the most advantageous timing and with limited competition at the time of the offering. In acting in the interests of its various clients, MUNICIPAL ADVISOR could potentially face a conflict of interest arising from these competing client interests. In other cases, as a broker-dealer that engages in underwritings of new issuances of municipal securities by other municipal entities, the interests of MUNICIPAL ADVISOR to achieve a successful and profitable underwriting for its municipal entity underwriting clients could potentially constitute a conflict of interest if, as in the example above, the municipal entities that MUNICIPAL ADVISOR serves as underwriter or municipal advisor have competing interests in seeking to access the new issue market with the most advantageous timing and with limited competition at the time of the offering. None of these other engagements or relationships would impair MUNICIPAL ADVISOR's ability to fulfill its regulatory duties to CLIENT.

Broker-Dealer and Investment Advisory Business.

MUNICIPAL ADVISOR is a broker-dealer and investment advisory firm that engages in a broad range of securities-related activities to service its clients, in addition to serving as a municipal advisor or underwriter. Such securities-related activities, which may include but are not limited to the buying and selling of new issue and outstanding securities and investment advice in connection with such securities, including securities of CLIENT, may be undertaken on behalf of, or as counterparty to, CLIENT, personnel of CLIENT, and current or potential investors in the securities of CLIENT. These other clients may, from time to time and depending on the specific circumstances, have interests in conflict with those of CLIENT, such as when their buying or selling of CLIENT's securities may have an adverse effect on the market for CLIENT's securities, and the interests of such other clients could create the incentive for MUNICIPAL ADVISOR to make recommendations to CLIENT that could result in more advantageous pricing for the other clients. Furthermore, any potential conflict arising from MUNICIPAL ADVISOR effecting or otherwise assisting such other clients in connection with such transactions is mitigated by means of such activities being engaged in on customary terms through units of the MUNICIPAL ADVISOR that operate separately from MUNICIPAL ADVISOR's municipal advisory business, thereby reducing the likelihood that the interests of such other clients would have an impact on the services provided by MUNICIPAL ADVISOR to CLIENT under this Agreement.

In addition to the considerations above, the fact that MUNICIPAL ADVISOR's staff are engaged in support of these other business activities could create a conflict when multiple demands exist on a particular individual's time and resources. We reasonably believe that this conflict is mitigated by our staff's desire to complete CLIENT's work in a timely manner and consequently be compensated by MUNICIPAL ADVISOR for their efforts.

Other Business Relationships

MUNICIPAL ADVISOR may have existing or future business relationships, unrelated to CLIENT or MUNICIPAL ADVISOR's services to CLIENT, with underwriters, placement agents, attorneys, accountants, financial institutions, contractors or other entities whose services it may recommend to CLIENT or whom CLIENT may select on its own initiative. MUNICIPAL ADVISOR's business relationships with such entities may include payments or referrals made to Advisor by such entities or payments or referrals made by Advisor to such entities in connection with matters wholly unrelated to CLIENT's business or activities. Because under no circumstances will Advisor accept any form of payment or other remuneration, directly or indirectly, from any third party in connection with Advisor's services to CLIENT, Advisor believes that none of these other engagements or relationships would create a material conflict or otherwise impair MUNICIPAL ADVISOR's ability to fulfill its regulatory duties to CLIENT.

Secondary Market Transactions in CLIENT's Securities.

MUNICIPAL ADVISOR, in connection with its sales and trading activities, may take a principal position in securities, including securities of CLIENT, and therefore MUNICIPAL ADVISOR could have interests in conflict with those of CLIENT with respect to the value of CLIENT's securities while held in inventory and the levels of mark-up or mark-down that may be available in connection with purchases and sales thereof. In particular, MUNICIPAL ADVISOR or its affiliates may submit orders for and acquire CLIENT's securities issued in an Issue under the Agreement from members of the underwriting syndicate, either for its own account or for the accounts of its customers. This activity may result in a conflict of interest with CLIENT in that it could create the incentive for MUNICIPAL ADVISOR to make recommendations to CLIENT that could result in more advantageous pricing of CLIENT's bond in the marketplace. Any such conflict is mitigated by means of such activities being engaged in on customary terms through staff members of the MUNICIPAL ADVISOR that operate independently from MUNICIPAL ADVISOR's municipal advisory business, thereby reducing the likelihood that such investment activities would have an impact on the services provided by MUNICIPAL ADVISOR to CLIENT under this Agreement.

Other Conflicts of Interest.

None.

(b) *Disclosures of Information Regarding Legal Events and Disciplinary History*. MSRB Rule G-42 requires that municipal advisors provide to their clients certain disclosures of legal or disciplinary events material to its client's evaluation of the municipal advisor or the integrity of the municipal advisor's management or advisory personnel. Accordingly, Municipal Advisor addresses below the required disclosures and related information in connection with such disclosures.

Required disclosures include specific information about any criminal actions, regulatory actions, investigations, terminations, judgments, liens, civil judicial actions, customer complaints, arbitrations and civil litigation. Municipal Advisor and members of its staff have been subject to various such legal or disciplinary events. Municipal Advisor reasonably believes that it as an entity has no such events that may be material to CLIENT's evaluation of Municipal Advisor as such. However, during its 88 years as a broker/dealer, Municipal Advisor has accumulated a number of such events related to its broker/dealer business as such and CLIENT may wish to review these. Members of MA's staff who have also been registered representatives of one or more broker/dealers have disclosures which could potentially be material to CLIENT's evaluation. Specific instances of such events can be found in Item 9 of our Form MA and, for staff members, Item 6 of Forms MA-I. Direct links to all of this information for the firm and each individual are provided on our website at: https://www.wulffhansen.com/municipal-advisor-disclosures/.

The date of the last material change to a legal or disciplinary event disclosure on any Form MA or Form MA-I filed by Municipal Advisor with the SEC is December 10, 2019, which change consisted of adding historical disclosures about a newly affiliated third-party accountant. The disclosures were not related to the municipal advisory business.

- (c) **Customer Protections.** Municipal Advisor is registered with the Securities and Exchange Commission and the Municipal Securities Rulemaking Board. The latter's website is located at www.msrb.org. A municipal advisory client brochure is available on that website that describes the protections that may be provided by the MSRB's rules and how a client may file a complaint with an appropriate regulatory authority.
- (d) **Future Supplemental Disclosures.** As required by MSRB Rule G-42, this information may be supplemented or amended, from time to time as needed, to reflect changed circumstances resulting in new conflicts of interest or changes in the conflicts of interest described above, or to provide updated information with regard to any legal or disciplinary events of Municipal Advisor. Municipal Advisor will provide CLIENT with any such supplement or amendment as it becomes available throughout the term of the Agreement.

7. <u>Choice of Law.</u>

This Agreement shall be construed and given effect in accordance with the laws of the State of California.

- **8.** <u>Entire Agreement.</u> This instrument, including all Addenda and Appendices hereto, contains the entire agreement between the parties relating to the rights herein granted and obligations herein assumed. This Agreement may not be amended, supplemented or modified except by means of a written instrument executed by both parties.
- **Severability.** If any provision of this Agreement is, or is held or deemed to be, invalid, inoperative or unenforceable as applied in any particular case in any jurisdiction or jurisdictions because it conflicts with any provisions of any constitution, statute, rule or public policy, or for any other reason, such circumstances shall not make the provision in question invalid, inoperative or unenforceable in any other case or circumstance, or make any other provision or provisions of this Agreement invalid, inoperative or unenforceable to any extent whatever.

DISCLOSURE OF CONFLICTS OF INTEREST WITH VARIOUS FORMS OF COMPENSATION

The Municipal Securities Rulemaking Board requires us, as your Advisor, to provide written disclosure to you about the actual or potential conflicts of interest presented by various forms of compensation. We must provide this disclosure unless you have required that a particular form of compensation be used. You should select a form of compensation that best meets your needs and the agreed upon scope of services.

<u>Forms of compensation</u>; <u>potential conflicts</u>. The forms of compensation for Advisors vary according to the nature of the engagement and requirements of the client, among other factors. Various forms of compensation present actual or potential conflicts of interest because they may create an incentive for an Advisor to recommend one course of action over another if it is more beneficial to the Advisor to do so. This document discusses various forms of compensation and the timing of payments to the Advisor.

Fixed fee. Under a fixed fee form of compensation, the Advisor is paid a fixed amount established at the outset of the transaction. This form of compensation presents a potential conflict of interest because, if the transaction requires more work than originally contemplated, the advisor may suffer a loss. Thus, the advisor may recommend less time-consuming alternatives, or fail to do a thorough analysis of alternatives. There may be additional conflicts of interest if the Advisor's fee is contingent upon the successful completion of a financing, as described below.

Hourly fee. Under an hourly fee form of compensation, the Advisor is paid an amount equal to the number of hours worked by the advisor times an agreed-upon hourly billing rate. This form of compensation presents a potential conflict of interest if the client and the Advisor do not agree on a reasonable maximum amount at the outset of the engagement, because the advisor does not have a financial incentive to recommend alternatives that would result in fewer hours worked. In some cases, an hourly fee may be applied against a retainer (*e.g.*, a retainer payable monthly), in which case it is payable whether or not a financing closes. Alternatively, it may be contingent upon the successful completion of a financing, in which case there may be additional conflicts of interest, as described below.

Fee contingent upon the completion of a financing or other transaction. Under a contingent fee form of compensation, payment of an Advisor's fee is dependent upon the successful completion of a financing or other transaction. Although this form of compensation may be customary for the client, it presents a conflict because the Advisor may have an incentive to recommend unnecessary financings or financings that are disadvantageous to the client. For example, when facts or circumstances arise that could cause the financing or other transaction to be delayed or fail to close, an Advisor may have an incentive to discourage a full consideration of such facts and circumstances, or to discourage consideration of alternatives that may result in the cancellation of the financing or other transaction.

<u>Fee paid under a retainer agreement.</u> Under a retainer agreement, fees are paid to an Advisor periodically (*e.g.*, monthly) and are not contingent upon the completion of a financing or other transaction. Fees paid under a retainer agreement may be calculated on a fixed fee basis (*e.g.*, a fixed fee per month regardless of the number of hours worked) or an hourly basis (*e.g.*, a minimum monthly payment, with additional amounts payable if a certain number of hours worked is exceeded). A retainer agreement does not present the conflicts associated with a contingent fee arrangement (described above).

Fee based upon principal or notional amount and term of transaction. Under this form of compensation, the Advisor's fee is based upon a percentage of the principal amount of an issue of securities (*e.g.*, bonds) or, in the case of a derivative, the present value of or notional amount and term of the derivative. This form of compensation presents a conflict of interest because the advisor may have an incentive to advise the client to increase the size of the securities issue or modify the derivative for the purpose of increasing the Advisor's compensation.

ADDENDUM TO MUNICIPAL ADVISORY AGREEMENT

Addendum 1

1. Purpose

This Addendum 1 to the Municipal Advisory Agreement dated March 28, 2024 between the City of Guadalupe (hereafter, "CLIENT") and Wulff, Hansen & Co. (hereafter, "Municipal Advisor" or "Advisor" or "MA") specifies and describes specific municipal advisory services to be performed by Municipal Advisor under that Agreement.

2. Services

2.1 Scope of Services

Municipal Advisor will provide the following services to CLIENT pursuant to this Addendum:

- Develop a schedule of tasks, milestones, deadlines, etc. consistent with placing a general obligation bond measure on the November 5, 2024 general election ballot to finance a portion of the Royal Theatre Revitalization Project;
- Assist the City in determining the appropriate size, term-to-maturity and principal amortization schedule for the proposed general obligation bond issue;
- Estimate the annual cost of debt repayment for the proposed general obligation bond issue, for various categories of property taxpayers within in the City (e.g. single-family residential, multi-family residential, commercial, industrial, agricultural, etc.);
- Assist bond counsel in obtaining data, documents, etc. that may be required to ensure compliance with applicable Federal, State and local laws and regulations, and assist bond counsel in drafting the Ballot Measure, Tax Rate Statement and related matters;
- Attend City Council meetings and workshops in person or via zoom as requested, to provide progress reports and answer questions;

2.2 Limitations on Scope of Services

The services to be provided by Municipal Advisor to CLIENT pursuant to this Addendum are subject to the following limitations in addition to those described in the Agreement.

As a Member of the California State Treasurer's Office (STO) Municipal Advisor Pool, Advisor is periodically required to sign the State's "BOND CAMPAIGN CONTRIBUTION AND SERVICES PROHIBITION, MUNICIPAL ADVISOR CERTIFICATION" form certifying to STO that it has not made any contribution to a Bond Ballot Campaign of any public entity with whom it has done municipal advisory business during the preceding two-year period. Since such contributions are defined to include in-kind contributions as well as cash, Municipal Advisor is thus prohibited from providing such contributions in connection with this engagement.

3. Termination

The provisions of this Addendum 1 shall terminate and thereafter be null and void upon March 28, 2025. This Addendum 1 may only be extended or amended by a written agreement between CLIENT and Wulff, Hansen & Co.

4. Fees

With regard to Services to be provided by Municipal Adviser under this Addendum 1, Municipal Advisor shall be compensated as follows:

\$5,000 which amount includes reimbursement for out-of-pocket travel expenses, payable in two equal \$2,500

installments to be invoiced on or about July 31, 2024 and November 30, 2024.

5. Conflicts of Interest

Municipal Advisor is not aware of any additional material conflicts of interest to which it is subject in the context of this Addendum 1 other than those previously disclosed to CLIENT in connection with the Agreement.

WHEREAS, the City has diligently worked to raise the vast majority of funding needed for the Royal Theater Renovation Project and needs additional funds to reach its goal; and

WHEREAS, the City Council authorized the hiring of a financing team composed of Jones Hall, A Professional Law Corporation, and Wulff, Hansen & Co., as municipal advisor, at its meeting on March 26, 2023, to explore placing a bond measure on the November 2024 ballot for the Royal Theater Renovation Project; and

WHEREAS, at its meeting on March 26, 2024, the City Council authorized the hiring of a bond financing team composed of Jones Hall, A Professional Law Corporation, in an amount up to \$10,000, and Wulff, Hansen & Co., as municipal advisor, in an amount up to \$5,000, to explore placing a bond measure on the November 2024 ballot for the Royal Theater Renovation Project; and

WHEREAS, the professional services agreements with Jones Hall, A Professional Law Corporation, as bond counsel to the City, and Wulff, Hansen & Co., as municipal advisor to the City, with respect to the potential bond measure and attached to the staff report for this item, have been reviewed by the City Council.

1. New Transit Shelter on Obispo

Attachment 1 is photos of the new transit shelter at Obispo & Amber Streets. Rudy and Juan did a great job at the installation.

2. <u>Federal Earmark – Proposed Senior Center Project</u>

The city submitted the earmark request in the amount of \$2M for the proposed senior center building renovation/upgrades to Senator Padilla's office (Attachment 2).

3. Potential California Building Forward Library Grant

The City Administrator and the Grant Consultant (Townsend Public Affairs) are researching Library project funding for Guadalupe. There is a grant called the California Building Forward Library Program, however it's currently closed. Townsend said this is a good one for the library project and they will reach out to them to find out when it will open again...more to come later but this sounds promising.

4. Hwy 166/Black Road construction

The SBCAG team wants to provide an update to the City Council in May on the Hwy 166/Black Road Project that will be starting construction.

5. Escalante Meadows Stie Walk Invitation

The Escalante Meadows Development Company will be holding a board meeting on Wednesday, May 8th followed by a site walk at 2:30pm. As community stakeholders in the project, they want to invite key city staff and council to join them for the site walk so you can see the progress being made. Construction is progressing nicely, but it won't be completed until late this year or early next year. Please let the city administrator know if you are available able to attend.

6. New School – Safe Routes to School Grant

On April 2nd, the City Engineer Jeff van den Eikhof and the City Administrator were on a zoom call with SBCAG regarding the Measure A North County Safe Routes to School, Bicycle and Pedestrian Program, Cycle 4 projects (SRTS) grant.

The staff want to thank everyone who participated in the process of applying for the SRTS grant. The following Agencies received full funding: Buellton, Lompoc, and the County of Santa Barbara.

Guadalupe's project cost of \$481,000 was not fully funded, only a partial amount of just under \$105K which was the remaining amount left from those fully funded.

Although disappointed, staff are pleased to at least to receive \$105k, regardless.

SBCAG's Reason: Measure A funds don't typically fund School projects. SRTS funding usually fund safe routes to the school.

Jeff and Todd are not giving up. Both plan on finding other project funding and will work with the Grant writing team to apply for Active Transportation Program (ATP) funds due on June 17 and use the \$110K as leverage to complete the project.

The ATP provides funding to communities throughout California to support infrastructure projects, non-infrastructure projects and plans to further these goals.

Attachment 3 illustrates the scoring committee's project recommendations.

Maya Kulkarni, Transportation Planner 1 for the SBCAG will be presenting the project recommendations to the North County Subregional Committee on May 8th for approval by the Board on May 16th. Once the Board approves the program of projects, they can begin signing cooperative agreements so the city can start getting reimbursed for our project.

7. Planning Department Mission Statement

Below is the Planning and Building Departments new Mission Statement:

Mission Statement

Guide land use and development consistent with the 2042 General Plan, Zoning Codes, and related regulations, by providing accurate, timely, and courteous professional and technical services to our customers, to maintain the City's unique quality of life, protect public safety and the environment and promote economic vitality for current and future generations.

8. Real Property 4646 Tenth Street Appraisal (Former Als Union)

City staff are obtaining quotes from commercial appraisers for a valuation appraisal to assist with city decisions regarding the former Al's Union property.

The scope of work for this engagement will generally include:

- Subject Property Site Visit
- Survey for Subject Property Details
- Review of Submitted Data
- Survey for Statistical and Market Data
- Data Comparison Analysis
- Estimation of Market Value

9. Master Plan for Aging in Guadalupe

Mayor Ariston Julian communicated with the Margaret Weiss, Project Coordinator, Santa Barbara County Master Plan for Aging (MPA) at the recent SBCAG Board Meeting. Council Member Christina Hernandez is also aware of this as she serves on the MPA Advisory Committee. According to them, our population of older adults will double from 2010 to 2030, when 1 in 4 people will be over age 60. They will be more diverse, live longer and will contribute in new ways to make our communities more vibrant. There will be challenges of more people staying in the workforce, more neighbors living alone, and many will struggle with disability and poverty. The local plan they are creating will begin to address these

concerns and will position them to move forward as new funding and resources become available.

They are tentatively going to give a presentation to the City Council at the April 23rd meeting. They can provide:

- an overview of the Master Plan for Aging, including statewide and local initiatives
- information on steps Guadalupe can take toward becoming an age-friendly community with our support
- an AARP Livability Index report showing Guadalupe age-friendly status, based on standardized metrics and policy points

An age-friendly plan can lead to a community that is healthier and happier for residents of all ages.

10. CALIFORNIA'S BUDGET SUBCOMMITTEE HEARINGS IN FULL SWING

The California State Legislature is set to reconvene from spring recess on April 1, with a busy schedule amidst ongoing budget subcommittee hearings for the Governor's proposed FY 24-25 State Budget. Facing a deficit of up to \$53 billion, Senate Democrats, led by Mike McGuire and Scott Wiener, announced plans to mitigate the shortfall through early budget actions, leveraging Rainy Day Funds and constitutional minimums to education. Governor Newsom's proposed budget announced in January includes significant implications for housing, notably through a \$300 million cut to the Regional Early Action Planning Grants 2.0 (REAP 2.0), potentially impacting several projects in Santa Barbara County. Legislative attention also turns to various bills that could affect virtual meetings, transportation funding, project planning, and rail setting a legislative agenda that seeks to navigate policy debates and the state's financial challenges. Gus Khouri of Khouri Consulting LLC shares all this and more in the March State Legislative Update.

11. ELECTORAL YEAR DYNAMICS LIKELY TO IMPACT FEDERAL FY2025 BUDGET DISCUSSIONS

In March, Congress successfully averted a potential government shutdown by finalizing the fiscal year 2024 appropriations, a significant effort given the year-long contention over federal spending levels. This achievement came with the passing and President Biden's signing of two sets of funding bills, comprising a total of twelve packages. These funding bills did not meet the increases President Biden initially targeted, but they notably rejected the substantial cuts House Republicans proposed. Simultaneously, President Biden put forward his fiscal year 2025 budget, kicking off the next funding cycle under the constraints of last year's debt limit and bipartisan budget agreements. Yet, with the electoral year stirring the pot, disruptions are expected, potentially delaying the appropriations process beyond its October 1 start of the new federal fiscal year. The City of Guadalupe is a small but diverse community located in the northern boundary of Santa Barbara County on the Central Coast of California. The small city of Guadalupe has an estimated population of 8,657, with 88% of residents identifying as Latino or Hispanic and with 27.7% of the population living in poverty. The median household income is \$58,449, far below the statewide MHI of \$84,097, and just 11.8% of residents have achieved a Bachelor's degree or higher. A senior center for the city will provide necessary services in an already underinvested community and serve as an evacuation center for natural disasters of extreme cold or heat. As the impacts of climate change grow, rural and coastal infrastructure must adapt to protect residents.

Due to the Covid-19 pandemic, senior citizens have been isolated from their community resources, making it extremely difficult to center and support the senior population in Guadalupe. Since its inception, the senior center in Guadalupe has served as a multi-use space primarily serving seniors and other community residents. Senior citizens in Guadalupe, especially those without resources, rely on the senior center to maintain their quality of life. Hot meals, educational classes, and computer rooms are all available at the senior center. More importantly, the city can provide wraparound services (transportation, legal aid, housing, etc.) to seniors because they are in a centralized hub. Local services are often inaccessible for seniors who may not have ways to travel consistently or who don't speak English as a second language stressing the need for communal senior spaces. Furthermore, the renovation will bring the senior center to code, making it ADA accessible.

While the senior center will serve as a communal space for those in need, it will also serve as a community resource and evacuation center for Guadalupe and the surrounding unincorporated community. As a coastal community, Guadalupe is subject to extreme weather conditions that destroy property and prevent the city from providing services in times of need. With storm surges, property damage, and rising waters there is a dire need for evacuation centers that serve as centralized locations to provide shelter, first aid, and centralized points for communication and information during disasters. The senior center can also serve as a warming center during periods of extreme cold weather, as well as a cooling center during the increasingly common heat waves experienced along the central coast. Furthermore, wildfires contaminate the air, and the senior center will have air filtration systems to protect vulnerable communities. According to the CalEnviroScreen 4.0, Guadalupe ranks in the 82nd percentile for asthma demonstrating the dire impacts contaminated air has on a community of farmworkers and the need for greater air protections. Marginalized communities face severe consequences such as displacement and migration from the impacts of climate change requiring underserved communities like Guadalupe to apply for federal funding to mitigate these effects. During the 2024 storms, Santa Barbara County was listed on California Governor Gavin Newsom's declared statewide emergency for counties that faced the greatest risk of danger and disaster demonstrating the need for investment in climate adaptation.

City Engineer Report March 2024

The following is a list of projects in various construction, design, or planning stages.

- Various Caltrans Projects Future Caltrans projects include the Hwy 1/166 Signalization Project, the ADA Improvement Project, the Santa Maria River Bridge Project, the Pavement Project through Guadalupe, and two shoulder widening projects on Hwy 1 both north and south of the City. The City Engineer has been working with Caltrans regarding the improvements to the downtown area and the bridge. The City Engineer met several times with Caltrans staff to discuss the various projects and review preliminary plans. The City Engineer also met with PG&E to discuss potential upgrades. The City provided the existing light poles, and PG&E installed them in 2008.
- Amtrak Station Improvements (Transit Hub) The City has received a Clean California Grant from the State of California. During a February City Council meeting, an agreement was signed between the City and Caltrans to secure the Clean California Grant funding. The City has received a notice to proceed from Caltrans. The Amtrak site was surveyed in March. This topographic and boundary survey is the first step in the project's design. The City Engineer has also negotiated an additional \$100,000 of LCTOP funding for the Transit Hub project. The SBCAG Board will approve this funding during a future meeting. Depending on the project costs, the project may include public restrooms, electric vehicle charging infrastructure, bicycle amenities, pervious pavers, improved signage, and site beautification upgrades. The total project funding is \$1.3 million.
- Central Park Renovation Project The City Engineer and staff reviewed the 70% plans for the
 Central Park Renovation Project and returned comments to the design team for revision. The design
 team has presented three options for fencing, including chain link, composite fencing, and concrete
 block. Based on cost and maintenance, the City Engineer recommends the composite fencing.
 Discussions are ongoing with cell providers about temporarily removing antennas to recoat the
 elevated tank.
- Leroy Park Phase II Improvements Andrew Goodwin Design (AGD) is preparing plans for Phase II at Leroy Park. The work includes a multi-purpose room and exterior site improvements. The 50% plan review set is scheduled for delivery for City review in early April. AGD will make a presentation to the Parks and Recreation Commission in April. A grant administered by the USDA funds the project.
- 303 Obispo Street Site Improvements The design of the 303 Obispo Street Site Improvements is ongoing. City staff holds bi-weekly meetings with PG&E and the design team regarding the project. The project includes charging facilities for future electric buses and electric fleet vehicles. The City Engineer has also started communications with Charge Point to provide the charging infrastructure. The previous provider, Proterra, has gone bankrupt and no longer provides the charging facilities.
- **Highway 1 and Pioneer Lift Stations** The Highway 1 Lift Station is currently waiting for the electrical switch gear to be provided. This equipment has an approximate 50-week lead time. The



Pioneer Lift Station cannot be constructed until the Highway 1 Lift Station is completed. The City Engineer is trying to determine the best time to send the Pioneer Lift Station out to bid. In March, the City Engineer met with HCD to discuss reporting requirements for the CDBG project funding.

• Waste Water Treatment Plant Improvements – The City is currently violating its permit from the Regional Water Quality Control Board. The City Engineer, City Administrator, and Michael K. Nunley and Associates Inc met with Regional Water Quality Control Board staff to discuss a Consolidation Planning Grant. If successful, this grant will allow the City to study the feasibility of connecting to the City of Santa Maria Wastewater Treatment Plant.

The Biolac portion of the WWTP is not functioning properly and needs to be repaired. A mid-year budget revision will transfer funds originally allocated for the Highway 1 Lift Station to the Waste Water Treatment Plant Improvements.

- Measure A Projects An application for Measure A North County Safe Routes to School, Bicycle and Pedestrian Program, Cycle 4 was prepared and submitted. The application is for funding for sidewalks at the new Guadalupe Jr High School and Guadalupe Early Learning Center (ELC).
- **City Hall Improvements**—The City Engineer met with Staff to discuss the repairs needed for City Hall. A bid package will be prepared for the roof and related systems.
- 11th Multi-use Path/Street Safe Routes to School Project Preliminary design work is occurring for the 11th Street Multi-use Path. This pathway starts at the People's Self-Help Housing Project and ends at Mary Buren School. It will include pedestrian and bicycle facilities. The project is funded by Measure A Cycle 3 Safe Routes to School Program and the Affordable Housing Sustainable Community Grant Program. The topographic and right-of-way survey was completed in March.
- West Main Street Improvements—Preliminary design work is underway for West Main
 Improvements, which will improve the area from Highway 1 to Julia Drive. The project will include
 pavement rehabilitation, striping, and minor pedestrian improvements.

Development

The following developments, which require engineering review/oversight, are in various phases.

- 12th Street Apartment
 - The site and public improvement plans were reviewed and returned to the applicant with corrections.
- New Jr. High School Site
 - An encroachment permit application was submitted and review for the school entrances.

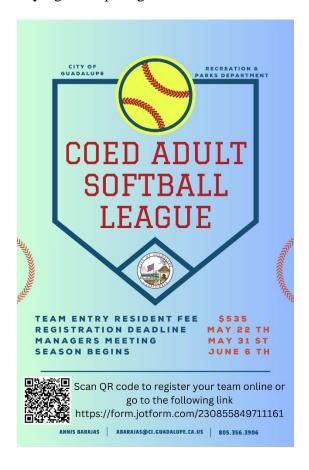

SUBJECT: Measure A Local Program of Projects

RECOMMENDATION:

That the City Council adopt Resolution No. 2024-29 which approves the 2024/25 through 2028/29 Measure A Local Program of Projects for the City of Guadalupe.

DISCUSSION:

Measure A Overview

Voter passage in November 2008 of the Road Repair, Traffic Relief and Transportation Safety Measure (Measure A), will provide approximately \$1.0 billion for transportation needs over 30 years within Santa Barbara County, from 2010-2040. The City of Guadalupe, and all other cities in the County, must submit an annual Measure A Local Program of Projects (POP) to the SBCAG Board to detail how the Measure A funds will be spent in Guadalupe.

In adopting the POP, the City Council "certifies that it will include in its budget an amount of local discretionary funding for local streets and roads sufficient to comply with the Maintenance of Effort [MOE] requirements contained in Section 27 of the Measure A Ordinance" The City met its MOE requirements over the last five-year window and will meet its MOE requirements of about \$300,000 over the next five-year window.

Measure A Revenues

Gas Tax, SB1, development impact fees, and Measure A fund balances will pay for the City's Street Paving Plan going forward. That plan calls for the City to spend about \$400,000 annually on street paving. For 2024, the street program will include rehabilitation of various streets.

Alternative Transportation

Measure A also requires the City to spend at least 5% of Measure A money on "Alternative Transportation Expenditures" – bicycle, pedestrian, and transit projects. The City has had no difficulty meeting this requirement in the past and will likely spend 6.0% of Measure A money during the five-year window on bike and pedestrian projects, including sidewalk maintenance and upgrade work done by our Street crew and required ADA sidewalk work made during street paving projects.

- SECTION 2. The City of Guadalupe hereby certifies that it will include in its budget an amount of local discretionary funding for local streets and roads sufficient to comply with the Maintenance of Effort requirements contained in Section 27 of the Ordinance; and,
- **SECTION 3.** The City of Guadalupe will not use Measure A revenue to replace private developer funding that has been committed to a transportation project or would otherwise be required under current City policies; and,
- **SECTION 4.** The City of Guadalupe has complied with all other applicable provisions.
- SECTION E. The City Clark is hereby authorized to make miner changes herein to address clarical errors

SECTION 5.	so long as substantial conformance of the intent of this document is maintained. In doing so the City Clerk shall consult with the City Administrator and City Attorney concerning any changes deemed necessary.

SUBJECT: Ordinance Regarding the Additional Duties and Obligations of the Mayor's Office

RECOMMENDATION:

That the City Council introduce on the first reading, and continue to its meeting of April 23, 2024, for second reading and adoption, an ordinance describing the additional duties and obligations of the Mayor's office.

BACKGROUND:

As is usually the case in cities throughout California, the office of the Mayor carries with it certain additional duties and obligations. In the City of Guadalupe, many of these additional duties and obligations have been established by long, historic, practice, but have not been described in a policy statement or in the Guadalupe Municipal Code (GMC). In light of the City Council's recent adoption of an ordinance providing a separate salary of \$250 per month in addition to the \$500 per month salary for all Council members, staff recommends the adoption of an ordinance setting forth and describing the additional duties and obligations of the City's Mayor as established by past practice both as a way of supporting the Council's decision to provide additional salary to the Mayor, and also, so that future occupants of this office will be informed about these additional duties and obligations.

DISCUSSION:

In the City, the Mayor is responsible for presiding over council meetings as the chair and represents the City as its official leader in both ceremonial and other occasions. Pursuant to GMC section 2.08.090.B.14, the City Administrator determines what is placed on the Council's agenda; however, historically, the Mayor may request items to be placed on the Council's agenda. The Mayor also is responsible for approving all Proclamations.

The Mayor signs all ordinances and resolutions that have been passed by the City Council and must sign all contracts unless the Council has designated other City officers to do so. The Mayor also appoints the *Mayor Pro Tem* who, pursuant to Government Code section 36802, has all of the authority of the Mayor in the event the Mayor is absent or unable to act.

In recognition of the additional duties and obligations of the office of the Mayor, the City Council recently approved an amendment to the GMC providing that the Mayor shall receive an additional \$250 per month in salary above what the other Councilmembers receive (GMC § 2.08.035).

ORDINANCE NO. 2024-518

AN ORDINANCE OF THE CITY OF GUADALUPE ADDING CHAPTER 2.10 TO TITLE 2 OF THE GUADALUPE MUNICIPAL CODE REGARDING THE ADDITIONAL DUTIES AND OBLIGATIONS OF THE MAYOR'S OFFICE

WHEREAS, as a result of a longstanding, historic, practice, the Mayor had performed certain duties and obligations in addition to those applicable to all members of the City Council, and some of these additional duties and obligations have not been described in a policy statement or in the Guadalupe Municipal Code; and

WHEREAS, the City Council recently recognized that the Mayor has additional and further responsibilities compared to the members of the City Council of the City of Guadalupe when it voted to increase Council members' salaries from \$150 to \$500 per month, and also, provided an additional \$250 per month for the Mayor's office; and

WHEREAS, the City Council wishes to identify at least some of the additional responsibilities of the Mayor's office so that anyone holding this office will be informed as to the expectation and a description of these additional duties and obligations placed upon the Mayor in addition to the duties and obligations for all members of the City Council.

NOW, THEREFORE, the City Council of the City of Guadalupe does hereby ordain as follows:

SECTION 1. Chapter 2.10 entitled "Additional Duties and Obligations of the Mayor" is hereby added to the Guadalupe Municipal Code as follows:

Section 2.10.010. Purpose.

In the City of Guadalupe, the Mayor performs certain additional duties and obligations established by long, historic, practice, but which have not been described in a policy statement or in the Guadalupe Municipal Code. The purpose of this Chapter is to describe some of the additional duties and obligations of the Mayor established by past practice both as a way of supporting the additional salary provided to the Mayor above the salary provided to all council members, and also, so that future occupants of this office will be informed about these additional duties and obligations.

Section 2.10.020. Additional Duties and Obligations of the Mayor.

In addition to all of the duties and obligations applicable to all council members, the Mayor has additional duties and obligations, including but not limited to the following:

- (a) The Mayor is responsible for presiding over council meetings as the chair.
- (b) The Mayor may represent the City as its official leader in both ceremonial and other occasions.
- (c) The Mayor is authorized to request that the City Administrator place an item or items on a Council's agenda.

- (d) The Mayor is responsible for approval of all administrative and official Proclamations of the City Council and is authorized to sign them.
- (e) The Mayor is authorized to name one of the other Councilmembers as the Mayor Pro Tem, subject to ratification by the City Council, who shall have all of the powers and duties of the Mayor, including presiding at meetings of the City Council, if the Mayor is absent or unable to act, pursuant to Government Code section 36802.
- (f) The Mayor must sign all ordinances and resolutions that have been passed by the City Council and must sign all contracts unless the Council has designated other City officers to do so.

SECTION 2. The City Council declares that each section, subsection, paragraph, subparagraph, sentence, clause, and phrase of this Ordinance is severable and independent of every other section, subsection, paragraph, subparagraph, sentence, clause, and phrase of this Ordinance. If any section, subsection, paragraph, subparagraph, sentence, clause, or phrase of this Ordinance is held invalid, the City Council declares it would have adopted the remaining provisions of this Ordinance irrespective of the portion held invalid, and further declares its express intent that the remaining portions of this Ordinance should remain in effect after the invalid portion has been eliminated

SECTION 3. The City Clerk is hereby authorized to make minor changes herein to address clerical errors, so long as substantial conformance of the intent of this document is maintained. In doing so, the City Clerk shall consult with the City Administrator and City Attorney concerning any changes deemed necessary.
