PUBLIC SAFETY DIRECTORS REPORT JUNE 25, 2024

POLICE

- Domestic Violence / Check the Welfare
 - a. Thirty-one (31) police call for service to evaluate. Most in Spanish speaking migrant community. Will look to work with social service agencies for better outreach to provide services, apprehend violators, and provide prevention information and better reporting of incidents.
- Traffic
 - a. Working with Caltrans and CHP to retrieve data on vehicular traffic flows, patterns, and enforcement on Hwy 166 (Flower Street to Guadalupe Street),
 Main Street (Guadalupe Street to Cesar Chaves Street), and Hwy 1 (Main and Guadalupe Street to 12th and Guadalupe Street)
- Fire Works Enforcement Leading up to 4th of July
 - a. Police presence has stepped up through usage of overtime to address illegal activity
 - b. We have and will continue to deploy drones for surveillance and enforcement
 - c. We have sent out flyers to advise the community on fines and enforcement regarding fireworks
 - d. We have and will continue to target past violators of the fireworks ordinance
 - e. We will set up surveillance cameras in specific areas to combat illegal firework activity.
 - f. We are working with a community volunteer to develop a specific social media page for police and fire to inform the community on criminal activity and integrate the Crime Stoppers Program more effectively.
 - g. We have community volunteers working with the police department to address public safety issues and assist public safety officers in non-threating situations.
 - h. Four (4) Fireworks Violation Citations issues for this month
- Staffing
 - a. Currently three (3) open police officer positions approved but not budgeted

FIRE

• Thirty-one (31) medical calls last month

- Seventeen (17) Weed Abatement letters sent out to local residents
- SAFER Grant
 - a. Grant Funded, three (3) Firefighters for three years. Still in review process
- Inspections
 - a. Fire Business License Inspection fees Paid increased by 99%, \$3,000 +
- Staffing
 - a. Currently one (1) Fire Engineer position, budgeted and unfilled
 - b. Two (2) Paid Call Firefighters (PCF's) in hiring process

CODE COMPLIANCE

 Department is now issuing "Code Compliance Orders" to expedite the process for compliance.

EMERGENCY PREPAREDNESS

- Generators
 - a. Two (2) generators have been purchased and are currently being built for the City of Guadalupe. One for City Hall, one for Public Safety
- Non-Congregate Sheltering January 2023 Flooding (Pioneer Street Incident)
 - a. FEMA reimbursement of \$50,000 is currently being reviewed for disbursement to city.
- Staffing
 - a. One (1) **open** Emergency Preparedness Coordinator position approved but not budgeted
