#### Good Afternoon to All,

I've received no clarification to my question below regarding my PRA request, so hopefully my request as submitted is adequate, if not, Juana, please let me know. I understand that the historical information requested will take additional time; however, the presentation of a report to the City Council should not delay providing me with the limited information that I have requested.

The attached article "Santa Maria sees record-high use of illegal fireworks, issues 65 citations" is attached. There are many more articles that report out the number of July 4<sup>th</sup> citations in numerous cities across both SB & SLO Counties; this information should be readily available on request. Another article of interest attached: "\$230,000 in citations issued for illegal fireworks in Woodland" discusses the use of an app to report the use of illegal fireworks. The last PDF attached is the Long Beach Fireworks Action Plan. They experienced a 34% decrease in calls this year due to enforcement; ALL fireworks are illegal there & in numerous cities throughout the state due to the threat of fire & injury.

It is ridiculous that this illegal activity persists year after year, getting progressively worse. The fireworks started Memorial Day weekend, they sporadically occur at Father's Day, Graduation, & during the weeks leading up to the 4<sup>th</sup> of July & they still continue. Last night was another sleepless night for me when the three explosions started at 10:30 PM & my neighbor's terrified dog Max barked non-stop until around 11:45 PM; my dog Selena was pacing in my bedroom & shaking. She finally settled in the shower where she seems to feel safer. Our dog Selena escaped her home/ yard in Guadalupe during the 4<sup>th</sup> of July in 2021 & her owner refused to pay her bail; we adopted her on 7/31/21. We have historically had to exit our home for the weekend closest to the 4<sup>th</sup> of July for many years for the sanity of our dogs. For the last two years our girl has kenneled in Arroyo Grande for a week. **We should not have to incur these expenses & inconveniences because of the City's lack of action.** 

The City Council has refused to ban all fireworks because Safe & Sane fireworks are a fundraiser; you have put a few dollars above the numerous residents with PTSD, concern of fire, & the unnecessary stress caused to family pets, their people, & other animals. Consider this my public comment: I'm requesting that a full ban on all fireworks be placed on an agenda for future discussion & action.
