## **Public Meetings to Discuss Consolidation of Guadalupe Transit with Santa Maria Regional Transit (SMRT)**

**Santa Maria**, **CA** –The City of Santa Maria and the City of Guadalupe announce a series of public meetings to discuss the consolidation of the City of Guadalupe's transit system (Flyer) with Santa Maria Regional Transit (SMRT). These meetings will provide an opportunity for community members to learn about the benefits of consolidation and share their valuable input.

Currently, both Santa Maria and Guadalupe operate separate transit systems, each managing its own operations, funding, and compliance requirements. However, the close connection between the two communities and the shared ridership highlight the potential benefits of a unified transit system.

## **Benefits of Consolidation:**

- Improved Service Reliability: Access to a larger pool of SMRT drivers and vehicles.
- **Enhanced Efficiency:** Streamlined administration, reduced duplication of efforts, and better resource allocation.
- Fare Uniformity: Consistent fare structure across both communities.
- Faster Technology Adoption: Quicker implementation of rider-centric technologies for Guadalupe residents.
- Better Coordination: Improved coordination between transit services.
- **Increased Accessibility:** Simplified navigation for riders traveling between Santa Maria and Guadalupe.
- State and Federal Compliance: Improved adherence to state and federal regulations.
- Electrification of Fleet: Streamlining the states requirements for fleet electrification.

Under the proposed consolidation, Guadalupe's transit routes would be integrated into the SMRT system, rebranded as SMRT routes (e.g., Route 40 and 41), and serviced by SMRT vehicles. SMRT would assume full responsibility for the administration of these routes, while Guadalupe would continue to support the service through the allocation of transit funding.
